### Overview of contributions and expenditures in 2013-2015

#### Note by the secretariat

#### Summary

The present document reports on the contributions and expenditures related to the implementation of the programme of work for the Convention on the Protection and Use of Transboundary Watercourses and International Lakes for the period 2013–2015 (ECE/MP.WAT/37/Add.1), which was adopted at the sixth session of the Meeting of the Parties.

At its tenth session (Geneva, 24–25 July 2012), the Working Group on Integrated Water Resources Management considered the implementation of the current programme of work and requested the secretariat to submit the present document to the seventh session of the Meeting of the Parties.

The Meeting of the Parties may wish:

- (a) To endorse the report on contributions and expenditures;
- (b) To express its gratitude to Parties to the Convention, especially to the lead Parties of activities, as well as to organizations and partners that have provided human and financial resources to implement the programme of work;
- (c) To call upon Parties and partners to continue providing financial support also for the implementation of the future programme of work.

#### VI. In-kind contributions

- 5. The Netherlands hosted and partly funded the Expert Scoping Workshop on Quantifying the Benefits of Transboundary Water Cooperation (Amsterdam, 6–7 June 2013).
- 6. Estonia hosted and partly funded the expert workshop "Beyond water: Regional economic integration and geopolitical benefits of transboundary water cooperation" (Tallinn, 28–29 January 2015).
- 7. The Netherlands provided in-kind expertise in the form of one of the lead experts for programme area 4 on climate change adaptation in transboundary basins.
- 8. Estonia supported the preparation of the publication *Counting our Gains: Policy Guidance Note on Identifying, Assessing and Communicating the Benefits of Transboundary Water Cooperation* (ECE/MP.WAT/47).

- 9. Numerous experts contributed to the preparation of the following publications: Water and Climate Change Adaptation in Transboundary Basins: Lessons Learned and Good Practices;<sup>2</sup> Counting our Gains: Policy Guidance Note on Identifying, Assessing and Communicating the Benefits of Transboundary Water Cooperation; and Reconciling Different Resource Uses in Transboundary Basins: Assessment of the Water-Food-Energy-Ecosystems Nexus (ECE/MP.WAT/46).<sup>3</sup>
- 10. Several institutions hosted meetings of the Implementation Committee: the International Commission for the Protection of the Danube River, the United Nations Office at Vienna, the University of Bologna and the University of London.
- 11. Lithuania provided in-kind support to the project on river basin management and climate change adaptation in the Neman Basin, e.g., by hosting and partly funding several project events.
- 12. Lebanon and Jordan provided in-kind support for their national events on the Water Convention that they hosted: "Workshop on the UNECE Water Convention: Key aspects and opportunities for Lebanon" (Beirut, 4–5 February 2015); and the "National workshop on frameworks for transboundary water cooperation: Focus on the UNECE Water Convention" (Amman, 10 March 2015).
- 13. The Alliance for Water Adaptation and the United States Army Corps of Engineers Institute for Water Resources provided support for the Dniester pilot project by funding several studies on the Dniester reservoirs and organizing technical workshops in Ukraine and the Republic of Moldova.
- 14. The Centre for Water Law Policy and Science of the University of Dundee provided in-kind support for promoting the Convention outside the ECE region.
- 15. The United Nations Educational, Scientific and Cultural Organization (UNESCO) provided support for the global opening of the Convention, including by translating the publication *Model Provisions on Transboundary Groundwaters*<sup>4</sup> (ECE/MP.WAT/40) into Arabic.
- 16. Several organizations and partners supported the global opening of and awareness-raising on the Convention, such as the Global Water Partnership (GWP), the International Network of Basin Organizations, the International Union for Conservation of Nature and many others.
- 17. The Global Environment Facility (GEF)/UNDP assisted in the organization of the workshop on "Assessing the water-food-energy-ecosystem nexus in transboundary basins under the Water Convention: Alazani/Ganikh pilot project" (Kachereti/Tbilisi, Georgia, 25–27 November 2013).
- 18. The GWP Central Asia supported the organization of the workshop on the Water-Food-Energy-Ecosystems Nexus Assessment in the Syr Darya River Basin (Astana, 2–4 December 2014).
