Item 3: Recent developments in the Global Energy Efficiency 21 (GEE21) Project

- 3. The Group of Experts will be informed of developments since the approval of the Global Energy Efficiency 21 (GEE21) Project by the Committee on Sustainable Energy at its seventeenth session on 19-21 November 2008, its subsequent launch at the Conference of Parties (COP-14) of the United Nations Framework Convention on Climate Change (UNFCCC) on 16 December 2008 in Poznan and the kick-off meeting of the Project on 4 June 2009 in Geneva.
- 4. The Group of Experts will be invited to consider the publication *Financing Global Climate Change Mitigation: Sources of Financing Energy Efficiency and Renewable Energy Investments,* presented at a side event to the COP-15 on 16 December 2009 in Copenhagen. It aims to provide an appraisal of the energy efficiency situation worldwide with guidance for future action, drawing on the work of the regional commissions of the United Nations.
- 5. The Group of Experts will be informed about the results of the twentieth session of the Steering Committee of the Energy Efficiency 21 Project, held on 3-5 June 2009, and the eighteenth session of the Committee on Sustainable Energy and its annual Energy Security Dialogue, held on 16-20 November 2009. The focus of the Dialogue was on energy security and the financial crisis.
