



#### **ACTIVITIES FOR NATIONAL PROJECT WEB-SITE**

Updating and posting new information is being made on the national project web-site and its maintenance, in particular:

 Analysis of current legislation of Ukraine in sphere of energy efficiency and renewable energy sources (approved during September 2009 - January 2011) was made and relevant information was posted on the project web-site;

Investment project database is being formed.



- Project Identification Forms for energy efficiency and renewable energy projects were translated into Ukrainian;
- More than 60 letters were prepared and sent to companies, organizations and institutions with the proposal:
  - 1) to fill in the project identification forms;
  - 2) to submit information concerning interest in cooperation with Eastern European Energy Efficiency Fund concerning implementation of energy efficiency projects and delegation managers for training.

 List of JI projects provided by National Environmental Investment Agency of Ukraine;


