Committee on Sustainable Energy Eighteenth session, Geneva, 18-20 November 2009 (Report ECE/ENERGY/80, para 21)

In relation to the Expert Group on Resource Classification, the Committee inter-alia:

- Approved the change of name to the Expert Group on Resource Classification and endorsed its TOR
- Approved the mandate of the Expert Group for a period of five years through 2014 (confirmed by ECE Executive Committee, 26 February 2010)
- Approved final text of United Nations Framework Classification for Fossil Energy and Mineral Reserves and Resources 2009 (UNFC-2009) as successor to UNFC-2004
- Requested that UNFC-2009 be issued as an addendum to the Committee report (ECE/ENERGY/80/Add.1) and to disseminate/promote the classification system

#### Committee on Sustainable Energy Eighteenth session, Geneva, 18-20 November 2009 (Report ECE/ENERGY/80, para 21)

In relation to the Expert Group on Resource Classification, the Committee inter-alia (continued):

- Requested that UNFC-2009 be issued as a United Nations publication in all six UN languages to facilitate further implementation of ECOSOC Resolution 2004/233
- Endorsed Expert Group programme of work for 2009/2010
- Requested the Expert Group to prepare appropriate documentation to support the programme of work for 2009/2010 that could include: (i) a report or discussion paper on the provision of specifications and guidelines for UNFC-2009; and (ii) case studies analyzing application of UNFC-2009
