# Sustainable Energy Sub-Programme

- Ensure access to affordable, clean energy; reduce greenhouse gas emissions and the carbon footprint of energy sector
- Develop normative instruments, including work on standards and best practice guidance in
  - Energy efficiency
  - Renewable energy
  - Clean electricity
  - Coal mine methane
  - Resource classification
  - Natural gas
- Work falls into 3 broad categories
  - Reconciling the reality of fossil fuels' enduring share of the energy mix with the need to address climate change
  - Enhancing integration of the region's energy markets
  - Facilitating the transition to a sustainable energy system

# Selected Achievements 2014-2015

- Recommendations to the UNFCCC\* about carbon capture and storage
- Best policy practices on energy efficiency; national case studies
- Dissemination of best practice guidance on coal mine methane; International Center of Excellence for Coal Mine Methane (Poland)
- Status report on renewable energy in the UNECE region
- Application of United Nations Framework Classification to injection projects for geological storage of CO<sub>2</sub>; guidelines for application to uranium and thorium resources
- 6<sup>th</sup> International Forum on Energy for Sustainable Development: Hammamet Declaration and Yerevan Statement of Common Action
