



2) How did you find accessing the teaser event online? (Using Webex, registration etc.)






Comment (1):

Yes, the existing lack of coordination between industrial safety and urban planning. Not adequate implementation of industrial safety rules in urban plans.




5) Was this event helpful for the preparation of your country presentation for the Sub-regional workshop in October 2021?

7) What do you believe should be the follow-up activities after this event and prior to the Sub-regional workshop in October 2021? *Comments (7):*

- Proposals for development strategies of implementation of TEIA conventions.
- It would be good to have another online event before October 2021.
- Maybe a short online meeting. (1 2 hrs) early spring to recap and to show the case studies in the repository.
- A key follow-up activity could be:
 - Reaching out to countries / contacts to submit good practices and lessons learned in land-use planning and industrial safety to be presented in the online UNECE Information Repository, which could then also be presented at the Subregional workshop in 2021 Other follow-up activities could include:
 - Additional guidance development: Guidance on implementing and strengthening public participation and consultation, in relation to plans or projects involving land-use planning and industrial safety issues, could be developed.
 - In order to support the implementation of the UNECE Guidance on Land-Use Planning, the Siting of Hazardous Activities and related Safety Aspects, a new, supplementary version of this guidance could be prepared that is targeted to administrations and practitioners at the local level, such as local planning authorities, city majors and other decision-making authorities.
 - Capacity development: an activity lead jointly by international organizations (including UNECE) and country representatives, could be implemented in the EECCA. This could include, for example, an assistance project on integrating land-use planning and industrial safety legislation, a twinning project, and/or a professional exchange programme for planning and safety experts in neighbouring countries to get together and cooperate.
- > How about drafting a series of surveys that could help countries find out what is good/missing in industrial safety and spatial planning cooperation, as well as in other fields of scope of UNECE TEIA? Idea fits with ongoing pandemic online work methods.
- Perhaps, the Sub-regional exercise regarding the improvement of the procedure related land use planning and industrial safety in transboundary context.
- ▶ I believe the format as used for the events so far work excellent. For now, I do not have additional suggestions.
