The role of the public in raising awareness and education of the population on the changes and climate protection (Articles 3 and 5 AC, Articles 4 and 6 UN FCCC, Article 10 KP)

Public participation in decision-making on specific activities that can have a significant impact on the climate (Article 6 AC, Article 4 of the UNFCCC, Article 10 KP)

Public discussions in the evaluation of the environmental impact of activities that can have a significant impact on the climate

Belarusian experience:

Public participation in the development of plans and programs related to climate change, in particular programs for mitigation and adaptation to climate change

 Involvement of public to the process of preparing the drafts of plans and programs related to climate change

Belarusian experience:

 The least developed component of public participation in climate issues

Public participation in the preparation of normative legal acts related to climate change (Article 8 AC, Article 6 of the UNFCCC, Article 10 KP)

 Involvement of the public in the preparation of drafts regulations relating to climate

Belarusian experience:

 Discussion of the draft laws of the Republic of Belarus "On Air Protection", "On the Climate"

Capacity building of the public on climate change (Article 3 AC, Articles 4-6 of the UNFCCC, Article 10 KP)

 Public with experience in the field of climate change, enriches it by participating in educational activities, participates in the preparation of teaching materials

Belarusian experience:

- The method of accounting of greenhouse gases emissions from drained and restored wetlands in the frames of the international project will be developed and tested, as well as the system of the sale of CO2 certificates in the voluntary carbon market
- Participation in international climate research

The role of the Aarhus Centre in strengthening cooperation between government agencies and the public on climate issues

- Assistance in carrying out public meetings of Environmental Coordination Council under the Ministry of Natural Resources, where the issues related to climate protection are consider
- Publication of the brochure about climate for young people and the media as part of an educational project SPARE
- Preparation section 8 "EDUCATION, TRAINING AND PUBLIC AWARENESS ON CLIMATE CHANGE" of the Fifth and Sixth national communications for the Implementation of the United Nations Framework Convention on Climate Change

- Participation in the preparation of the bill on public participation in environmental decision-making
- Publication of practical recommendations for public participation with the support of the OSCE
