## of the Steering Committee meeting on reviewing draft document «Strategy of water sector reformation» under

## National Policy Dialogues on IWRM in Tajikistan

24 November 2011 Dushanbe

Members of the Steering Committee, representatives of national working group on elaboration of legal and institutional documents on preparation to water sector reform in the Republis of Tajikistan of the Ministry of Melioration and Natural Resources of the Republic of Tajikistan, as well as Ms Elle Bekma, Head of the working group of the project «Supporting the Ministry of Melioration and Natural Resources and Water-Energy Council in elaboration of the Water Sector Strategy, plan of realization and investments in irrigation sub-sector» participated in revision of the draft document «Strategy of water sector reformation». - 6.Discussion of different non-irrigational elements of the draft strategy document;
- 7. Proposal of changes and additions to the draft strategy;
- 8. Conclusions of the meeting and discussion of the next meeting.

The main presenter Ms Elle Bekma put in the draft document «Strategy of water sector reformation» with regard to all items of the agenda. Following discussion of the agenda items participants of the meeting made the following decisions and recommendations:

- 2. To establish a working group on finalizing the draft document «Strategy of water sector reformation» on the level of representatives of the Steering Committee in order to finalize the document including all stakeholders.
- 3. To Ms Elle Bekma, Head of the working group of the project «Supporting the Ministry of Melioration and Natural Resources and Water-Energy Council in elaboration of the Water Sector Strategy, plan of realization and investments in irrigation sub-sector», to elaborate a Technical task for the members of the working group.
- 4. To ask UN ECE for funding of the working group under the National water policy on IWRM in Tajikistan project in 2012.
- 5. To the working group to submit finalized draft document «Strategy of water sector reformation».
