

# Post COVID-19 Recovery Action Plan for Informal Settlements in the UNECE Region Kyrgyzstan Local Stakeholder Workshop

### Rationale

In the context of the ongoing COVID-19 global crisis, UNECE is preparing a *Post COVID-19 Recovery Action Plan for Informal Settlements in the UNECE Region*. The Recovery Action Plan aims at providing cities with robust and efficient action measures to enhance the integration of informal settlements in the urban fabric while recovering from the crisis caused by the pandemic. The Plan is underpinned by assessment reports on informal settlements in four project cities: Tirana, Albania; Bishkek, Kyrgyzstan; Podgorica, Montenegro; and Skopje, North Macedonia.

The **Kyrgyzstan local stakeholder workshop** focuses on the pilot city Bishkek. The event is designed to:

- Present and discuss key findings of the draft local assessment report of Bishkek city as well as next steps to improve the situation in the informal settlements of Bishkek
- Raise awareness about the Post COVID-19 Recovery Action Plan for Informal Settlements in the UNECE Region and its key deliverables and
- Discuss how it could support the implementation of local measures in Bishkek in its specific context.

After a general introduction to the Post COVID-19 Recovery Action Plan for Informal Settlements in the UNECE Region, data from the city assessment report will be presented by the local consultant, followed by comments to the draft assessment report and an identification of priorities to address challenges of the informal settlements by local and national government representatives. Finally, local stakeholders are invited to discuss with the assessment team, the experts and government representatives from their perspectives on how the Regional Action Plan could support the implementation of the local measures.

Materials explaining the Plan's key measures in detail will be made available beforehand on UNECE's website.
