Report of the UNECE Meeting of Real Estate Market Advisory Group

Geneva, 12 May 2015

I. Introduction

1. UNECE Meeting of Real Estate Market Advisory Group (REM) was held in Geneva on 12 May 2015.

2. The list of participants is available in Annex 1. The REM meeting presentations are available at the UNECE website.¹

II. Presentation of the activities of the Committee on Housing and Land Management with a focus on the extension the mandate of the REM

3. The Chair of the Committee on Housing and Land Management informed the participants on the activities of the Committee under its programme of work 2014-2015. The Chair reported that REM terms of references were adopted by the Committee and the UNECE Executive Committee in 2014 for the period until the end of 2016.² She invited REM members to discuss ideas for the REM programme of work 2015-2016.

6. The Committee secretariat presented main results of the Committee's study on social housing and information on the preparations to the United Nations Conference on Housing and Sustainable Urban Development – HABITAT III, which will take in Quito, Ecuador, in October 2016. Participants were informed that the European regional consultation for the HABITAT III will be organised by the Government of Czech Republic in March 2016.

III. Development of proposals for the REM programme of work for 2015-2016

9. REM members were invited to review the Geneva UN Charter on Sustainable Housing³ and propose activities for the programme of work 2015-2016 based on their expertise. The Chair requested REM members to ensure that the programme of work supports the implementation of the Committee's programme of work, including the activities on the implementation of the Charter.

10. REM members formulated proposals for its programme of work.

10. The meeting participants agreed that the proposals for the programme of work will be communicated with the rest of the group by the end of June 2015. After possible comments from REM members, the updated draft programme of work will be presented as
