Introduction

The UNECE Committee on Housing and Land Management decided in 2012 to include the topic of "smart cities" as one of its priority activities in its programme of work 2014-2015 under the cluster "Sustainable urban development". Further, in 2014, the Committee launched the initiative "United Smart Cities", which is aimed at supporting sustainable urban development in the ECE region, with a special focus on countries with transition economies.

With the expansion of urban areas, there is an urgent need to make cities better functioning and more efficient. Many countries are adopting the concept of smart cities. Cities applying the smart city concept are not only based on sound and strong ICT infrastructure, but are also more economically productive, environmental friendly and socially viable for its citizens. Smart cities should be inclusive, safe, resilient, sustainable and "connected" and should:

- Ensure access to adequate and affordable housing
- Provide access to safe, affordable and sustainable transport systems
- Enhance inclusive and sustainable urbanization
- Safeguard their cultural and natural heritage
- Reduce the number of deaths, displacement and losses caused by disasters
- Reduce their environmental impact
- Provide universal access to safe and accessible green and public spaces
- Support positive economic, social and environmental links between urban and rural areas
- Integrate innovative technologies and ICT within the different sectors.¹
