### **Group of Experts on Energy Efficiency:** Main Activities

A. Exchange of know-how and best practices in selected economic sectors on how to significantly improve energy efficiency in the United Nations Economic Commission for Europe region

- Identify key operational policy priorities for member States
- Provide a platform for expanding already developed policies and measures across countries
- Develop **joint programmes** with leading institutions
- Organize information sharing activities on energy efficiency best practices and policies
- Identify **gaps in standards and regulations** and cooperate with other relevant organizations in addressing them
- Monitor and promote the results of World Bank's Readiness for Investment in Sustainable Energy (RISE) Initiative



### **Group of Experts on Energy Efficiency:** Main Activities (cont.)

**B. Exchange of know-how and best practices on the role of standards and guidelines to** significantly improve energy efficiency in the United Nations Economic Commission for Europe region

- Consider the results from the **regional survey on energy efficiency building standards**
- Explore the possibility of **establishing UNECE-wide standards for building energy efficiency** that covers new and existing buildings, as well as best practices for neighbourhoods and cities
- Explore the possibility to set up train-the-trainer seminars
- Establish a **match-making mechanism** to channel technical assistance to accelerate energy efficiency through pairing of institutions
- Joint Task Force on Energy Efficiency Standards in Buildings with the UNECE Committee on Housing and Land Management with participation of the UNECE Working Party on Regulatory Cooperation and Standardization Policies and other relevant stakeholders

- 5. Development of internationally recognized minimum energy performance standards.




