Objectives of the report

- To assess the current situation and major challenges in housing and urban development in the ECE region; and
- 2. To define the priorities for future action in the areas of housing and urban development in the ECE region.

A special focus will be on those policies, policy instruments, programmes and projects that have improved housing and urban development in the region.





Top challenges in housing and urban development

- Inefficient use of energy in the residential sector
- Lack of affordable solutions for young people who enter the housing market
- Limited access to affordable, quality and healthy housing in the market
- Lack of easy access for disabled and aged persons due to physical/architectural barriers

- Low political attention to housing and urban development issues
- Decreased housing affordability as result of the economic crisis and unemployment
- Deteriorated housing stock due to a lack of maintenance and investment

Update on the publication

- Informal note 1 Update on the preparation of the publication "Challenges and priorities in housing and urban development in ECE region"
- This publication will be the Committee's contribution to HABITAT III which will take place in 2016.
 - Information on the preparation of the publication was discussed at teh First session of the Preparatory Committee for HABITAT III in September 2014.



Timeline

- September 2012- Committee requests the secretariat to prepare the publication
- October 2013 Committee adopts on the report outline and that it would be its contribution to HABITAT III
- February 2014 Structure of the national reports was elaborated and the questionnaire was distributed to pilot countries
- June 2014 Committee Bureau meeting results of pilot study were reported, the final questionnaire was developed

Timeline cont...

- July September 2014 Secretariat distributed questionnaire to 56 member States and collects responses. Start of the regional analysis.
- October 2014 to May 2015 Regional analysis, collection of lacking national information
- June August 2015 Editing, formatting and finalization of study
- October 2015 Approval of the report at seventy-sixth session
