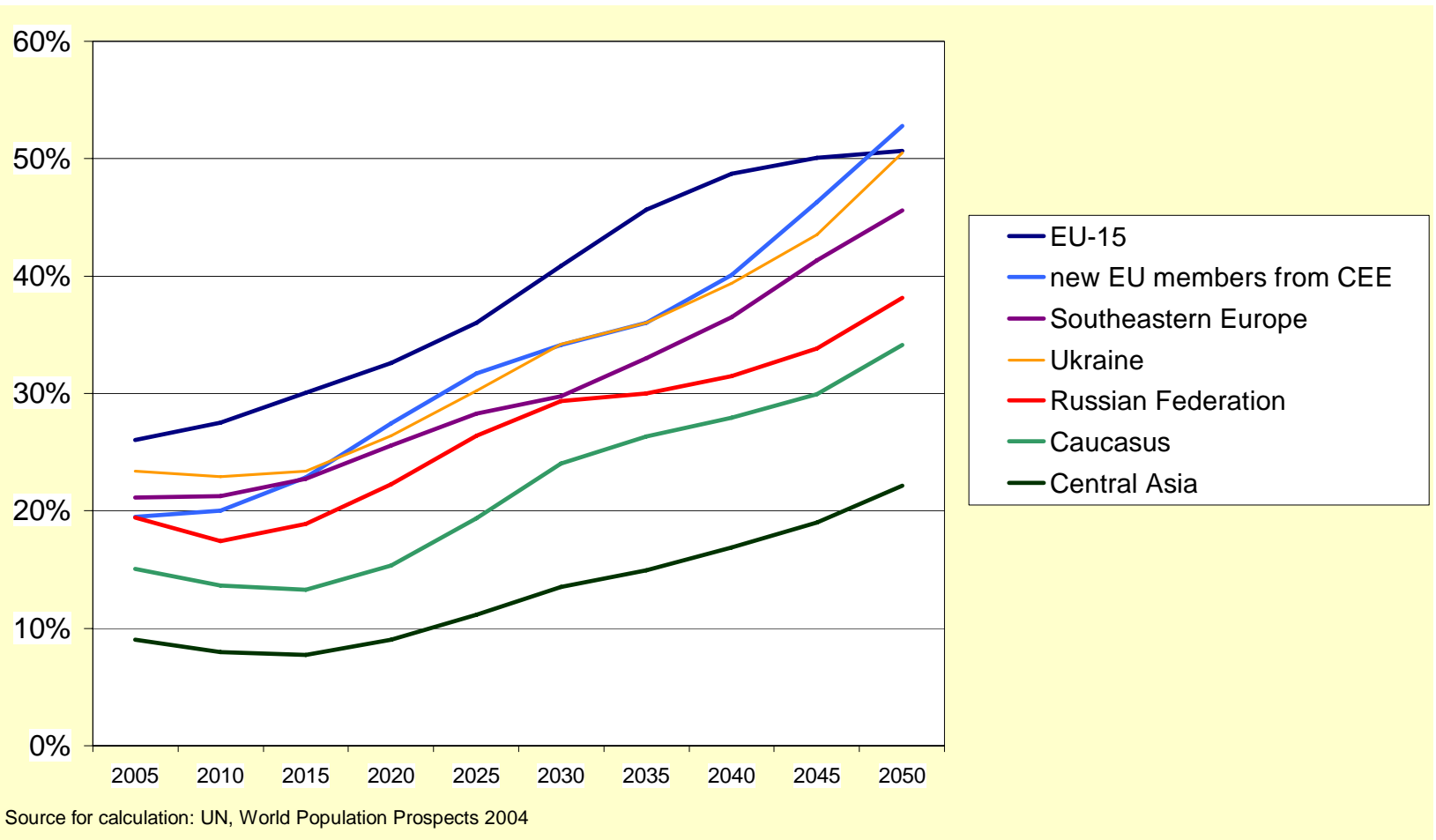

# Thematic panels (clusters of commitments)

- Policy actions aimed at achieving a society for all ages (1,8)
- Intergenerational solidarity and relationships in family and society (2,7,9)
- Population ageing : challenges and opportunities for economic growth and societal development (3)
- Adjustment of social protection systems and labour markets (4,5,6)
- Lessons from review and appraisal : new insights gained with the bottom-up participatory approach and from cooperation with civil society

# Preparation

- Expert group
  - Builds on the Task Force *Monitoring RIS*
  - Provides substantive inputs through the Preparatory Committee
- Preparatory Committee
  - Members States have been invited to delegate a representative; open-ended
  - Discusses substantive proposals, including proposals from the Expert Group
  - Elaborates the format and the agenda
  - Drafts the political declaration

# Meeting of Focal Points

## Segovia, Spain, 13-15 Nov 2006

- Establish the network / constituency: delegates from 27 countries in Segovia; 42 Member States have a focal point by now
- Provide assistance in conducting MIPAA review and appraisal on the national level
- Collect information on national level activities
- Broaden the range of countries involved in international exchange
- Deliver outputs of regional level projects to countries
- Discuss good practices

## Meeting of Task Force and Expert Group, Vienna, 26-27 February 2007

- Experts to address concrete questions on how the outcome of the Conference could have a desirable effect in their areas of expertise: draft papers on the key areas of MIPAA/RIS
- Propose topics for the political declaration
- Propose elements for the agenda
- Provide expert advice on the regional summary report based on the national country reports on the implementation of the Regional Implementation Strategy of the MIPAA.
- Conclusion of the work to be submitted to the Preparatory Committee



# Country reports

UNECE •

- Main underlying questions:
  - What has been done in our country in the areas covered by MIPAA/RIS since its adoption?
  - What was the impact of these actions on the quality of life and well-being of older people in our country?
- “Guidelines for Reporting on National Follow-up to MIPAA/RIS”
  - assist Member States in compiling report
  - ensure harmonised structure of country reports
- Background material for 2007 Conference on Ageing
- Compilation of summary report of ageing related developments across the UNECE region out of country reports

# Country reports: Structure

- General information related to ageing: demographic, economic indicators/social, political situation
- Review and appraisal by subject area
  - Country report organised along RIS commitments
  - Comment on implementation status of every RIS commitment
  - In-depth evaluation of one or more **national priority areas**
  - Bottom-up participatory approach for evaluation of one or more national priority areas
- Conclusion, outlook for the future

# Meeting of the Preparatory Committee, spring 2007

- Representatives of the UNECE Member States (normally national focal points on ageing)
- Representatives of civil society
- Elaborate and decide upon the content and modalities of the Conference
  - agenda
  - background document
  - draft declaration
- Inputs: Segovia meeting; Expert meeting
- Drafting group to finalize the draft declaration

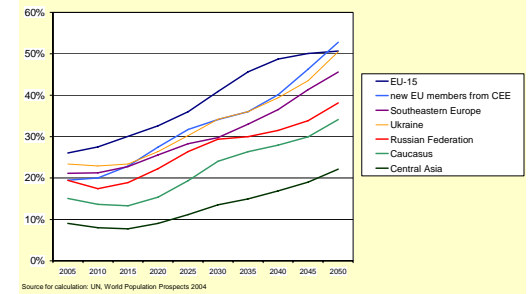

- commonalities among countries
- priority areas for future actions
- mechanism for monitoring
- promotion of data collection and research
- main responsible actors, partners
- cooperation with the UN
- means of cooperation
- relation to existing documents/strategies

# Organisational development at UNECE

- Proposal to establish a Forum on Population as an intergovernmental body under the UNECE
- Members: representatives of national authorities in the population or related areas of the UNECE member States
  - building on national focal points on ageing and on the International Working Group of the Generations and Gender Programme
- Objective: ensure a suitable intergovernmental mechanism for Population related work in the UNECE region, including follow-up to the Conference on Ageing
- First meeting in early 2008
