1. Background



a. The Vienna International Plan of Action on Ageing in 1982

- Several reviews and appraisals conducted the last one during 1997
- "the population over 60 has grown dramatically, yet the response has been minimal at best"
- "the progress in implementing the Plan of Action remains modest"

... why?

- No fault in the principles and recommendations!
- But difficulties in translating the plan into policy actions?
- Lack of resources (financial and analytical);
- Low priority to age-related issues; and
- Lack of coordination (within countries and internationally)

1. Background (continued)

MA:IMI

b. The Madrid International Plan of Action on Ageing in 2002

- MIPAA: Plan was adopted during the 2nd World Assembly on Ageing in Madrid – it emphasized in particular the need for enhanced and focused international cooperation;
- RIS: UNECE got involved in the follow-up process, to translate MIPAA into a Regional Implementation Strategy (RIS), and to assist national authorities in implementation and monitoring of their actions on ageing (Berlin Ministrial Conference 2002);
- MoU: Austrian Government supports this process; by initiating a cooperative arrangement involving the European Centre Vienna, UNECE and a newly formed Task Force and the UNECE, January 2004

1. Background (continued)

MA:IMI

c. Role envisaged for the MA:IMI project (2003-2008)

Overall objective: to "scientifically and technically assist governments in the monitoring of RIS" of the MIPAA within the UNECE region

Priorities:

- (1) Exchange of experiences in ageing-related policies
- (2) Data collection, Research and Analysis
- (3) Maintain a network of organisations active in the field of ageing

And,.... develop and monitor a set of agreed upon "indicators of achievement"

I. Task Force

- They are independent experts from various backgrounds: academics, civil servants, NGO representatives, UN office delegates.
- They are "to offer guidance and advice to the contents and priorities of the follow-up"
- Meetings:

13-14 April 2004, Madrid, Spain (the TF was constituted) 8-9 November 2004, Vienna, Austria 18-19 May 2005, Malta 29 May 2006, Copenhagen, Denmark 26-27 February 2007, Vienna, Austria

II. National Focal Points on Ageing

- National contacts in the 56 UNECE countries regarding issues on "Mainstreaming Ageing" and on the follow-up to the RIS
- They gather information about political processes, programmes and actions; and help and advise MA:IMI researchers on collecting and interpreting data for the indicators
- 1st Meeting:

13-15 November 2006, Segovia, Spain

2. Work Progress (continued)

III. NGO Network on Monitoring RIS

- They are national NGOs, specifically committed to watch ageing-related policies and other social policy measures in their respective countries
- They spread awareness of ageing-related issues and promote actions
 - exchange of information with Network members and other actors of the follow-up process
 - source of information for national Governments and International Institutions.

2. Work Progress (continued)



b. What priorities and what work undertaken?

Priority (1): Exchange of experiences in ageing-related policies

Achievements:

- Monitoring RIS Website (a tool central to our dissemination strategy; updated every 3 months; contains diverse ageing-related information)
- Publications (11 Books, 6 Policy Briefs, 2 special reports, and dozens of contributions to refereed journals and to media)
- Organisation of events (e.g. Conference on pension policy and pensioner poverty; international seminar series; workshops)
- Active participation in international conferences and seminars

2. Work Progress (continued)

MA:IMI

b. What priorities and what work undertaken?

Priority (2): Data collection, Research and Analysis

Achievements:

- List of indicators devised
- Data on these indicators collected
- Illustration of indicators (i.e. the booklet on country profiles)
- Research and analysis reported in publications, disseminated through organisation of events and via participation in international conferences and seminars

2. Work Progress (continued)

MA:IMI

b. What priorities and what work undertaken?

Priority (3): Maintain a network of organisations active in ageing

Achievements:

- Created, together with UNECE, several networks where experts, policymakers and civil society could meet (e.g. the Task Force, the National Focal Points on Ageing, the NGO Network on Monitoring RIS, External Expert Networks for Mainstreaming Ageing Indicator work)
- Contacts maintained through Monitoring RIS Website (30 websites of NGOs, other relevant actors linked to the website).
- By involving local and international NGOs in all the events we organise.

MRIS Website is central to our dissemination strategy....!

2. Indicators of achievement

MA:IMI

- List of indicators prepared, in consultation with international experts; data on these indicators compiled;
- Core set and others; across four domains:
 - 1. Demographic factors
 - 2. Income & wealth
 - 3. Labour market participation
 - 4. Social protection & financial sustainability
- Work also undertaken towards Long Term Care and Quality of Life indicators

Operationalization is a process, thus there is a continuous effort to include new data and update existing ones!

3. The future work programme

MA:IMI

- a. Why continue into the 2nd phase?
- MIPAA/RIS: Continuation of our highly valued work in the international cooperation in the 2nd cycle of the MIPAA /RIS, with the benefit of all the expertise attained during the 1st phase of the project;
- **Time urgency:** The next 5-10 years is critical in many respects, but mainly because the 'demographic bonus' is coming to an end; shrinking population phenomenon will be faced; and comparative research and dissemination will be invaluable.
- **Extended work programme:** Additional work planned that is essential for monitoring and evaluation of national policy practices and international collaboration

3. The future work programme

MA:IMI

b. Work programme planned for the 2nd phase

- Indicators: Updating of data on existing set of indicators; new set of indicators on Long-term care and Gender-specific mainstreaming ageing indicators; Quality of Life indicators;
- Monitoring RIS website: The KIMSU unit will continue its good work in updating information on the website; some restructuring
- International events: One technical workshop each year; two international conferences; international seminars
- Publications: Publication of policy briefs, research reports and books; and
- Newsletters alerts: Timely dissemination of information UNECE countries via newsletter alerts.

Work progress during 2008

✓ Indicators:

- Booklet "Some Facts & Figures on Ageing in Eastern Europe", produced for the joint AARP-ECV event (23-24 October 2008)
- Further progress in designing Long Term Care indicators and in collecting institutional information and data

✓ Publications:

- Forthcoming book "Women's Work and Pensions" (by Marin and Zolyomi) brings out some of the initial work on genderspecific MA:IMI indicators (including chapters by the MA:IMI team)
- Forthcoming book "Long term care for older people in Europe: Facts and Figures" (by Huber, Hoffmann and Rodrigues)

- The 1st stage of the MA:IMI project has been considered a take-off stage. This work continues with new vigour and priorities, and with all the benefits of expertise gained during the 1st phase.
- Work programme during the first year of the 2nd phase has been very rewarding.
- As for the financing of this work, ECV has firm commitments by about half a dozen governments to support continuation of MA:IMI into its 2nd phase (2008-2012); financing also from the European Commission.
- The financing needs to be further consolidated still a good part of this work subsidised by the European Centre.
