Introduction

In the first cycle of the global review and appraisal of the Madrid International Plan of Action on Ageing (MIPAA) (E/CN.5/2006/2), the Commission for Social Development mandated Regional Commissions to convene regional conferences (pending the availability of sufficient resources) to consider the findings of national reviews, share experiences and good practices, and identify priorities for future action, and to submit the findings to the Commission for Social Development in 2008. The UNECE Executive Committee approved the Work Plan on Population (ECE/EX/2007/L.4), which includes convening such conferences and the related preparatory meetings. The first meeting of the Preparatory Committee for the 2007 UNECE Conference on Ageing is expected to elaborate the content and decide on the modalities of the Conference, including the agenda, the background documents and the political declaration.
