(a) Policy briefs with good practice examples

In accordance with the work programme, the secretariat has prepared two policy briefs based on member States' contributions: on tapping the potential of volunteering; and on age-friendly employment policies and practices. The secretariat will present the Working Group with these policy briefs and outline the steps taken in their preparation.
- 6. The Working Group will be invited to comment on those briefs and propose examples of good practice.
- 7. The secretariat will explain the use of the updated database of good practices.
- 8. The Working Group will be invited to make proposals on the dissemination and use of policy briefs, as well as on the format and content of future briefs.

gender issues and on long-term care and the related methodological descriptions, and will also present its work on the website and the mainstreaming ageing newsletter.

10. The Working Group will be invited to discuss the activities presented and to advise on future steps, especially on the use of indicators for the second review and appraisal of the Regional Implementation Strategy for the Madrid International Plan of Action on Ageing (UNECE RIS/MIPAA).

(c) Capacity development

- 11. The representative of Armenia will present actions undertaken after preparation of its national Road Map on Mainstreaming Ageing and the draft strategy and action plan emanating from it.
- 12. The representative of Republic of Moldova will inform participants about progress in preparing its national Road Map for Mainstreaming Ageing.
- 13. The secretariat will provide an overview of work in progress with the Road Maps for Mainstreaming Ageing and a capacity development training workshop, which is being jointly undertaken by the United Nations Department of Economic and Social Affairs, UNECE and the United Nations Population Fund in Republic of Moldova.
- 14. The Working Group will be informed about the plans and developments with regard to a subregional capacity development training workshop on community services for older persons in Israel.
- 15. The representative of the Czech Republic will report on its plans to organize a training workshop.
- 16. The Working Group will be invited to discuss the information provided. The delegates may wish to put forward proposals for capacity-building activities in their respective countries. Potential donor countries will be invited to propose ways to support capacity development activities.

(d) Analysis of intergenerational relationships
