- 5. The Chair will provide an overview of the discussions at the Fifth Bureau meeting on 21-22 May, 2013 in Belgrade (Serbia).
- 6. The Working Group will review the implementation of its work programme during 2013:
 - The Bureau will report on progress made by four discussion groups initiated at the 5th WGA meeting.
 - The secretariat will present the Policy Brief on Abuse of Older Persons developed in the course of 2013. The Working Group will be invited to make proposals on the dissemination and use of the policy brief as well as for its translation.
 - The secretariat will present the results of self-evaluation exercise on developing Road maps on ageing in Armenia and the Republic of Moldova. The brief information will be provided on other capacity development activities: the postponement of the training workshop, planned for April 2013 in Haifa (Israel) and the workshop on the Road Map implementation in the Republic of Moldova (September 2013).
