ESFRI = European Strategy Forum on Research Infrastructures

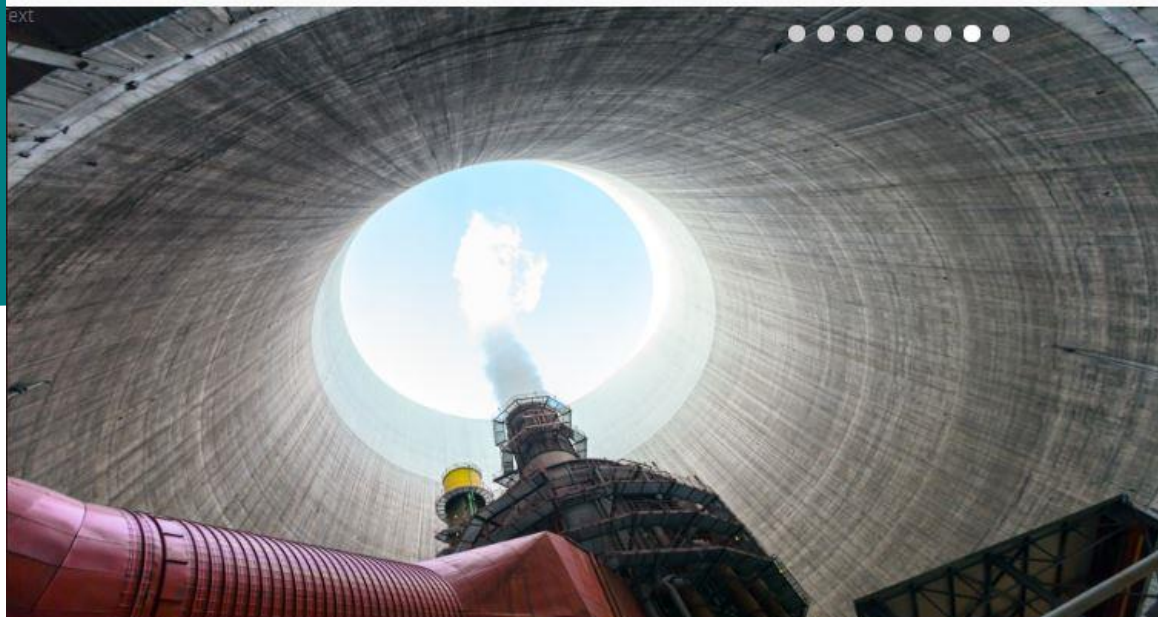


ESFRI
