SELECTION OF STATISTICAL AREAS FOR IN-DEPTH REVIEW BY THE CES BUREAU IN FEBRUARY 2006

Note prepared by the ECE Secretariat

1. At its February 2005 meeting, the CES Bureau decided that a survey to select the statistical areas for in-depth review by the Bureau in February 2006 be carried out at the time of the 2005 CES plenary session.

2. The CES Bureau reviews each year, usually in February, a few selected statistical areas as classified in the Integrated Presentation (IP) of International Statistical Work Programmes. The review is based on Rapporteurs' Reports, which identify important issues and problems in the given areas that require the attention of the top management of national and international statistical agencies. The review is focused on issues dealing with coordination and gaps in international statistical work. The aim of the review is to make recommendations on how to improve the coordination of international work in the selected domains.

3. In February 2005, the Bureau reviewed the following five statistical areas: (i) technical cooperation; (ii) migration statistics; (iii) income and consumption; (iv) labour statistics, and (v) transport statistics. Migration statistics was selected for in-depth review by the Conference at its annual plenary session in June 2005.

4. The statistical areas for review in 2006 will be selected by the Bureau on the basis of the survey that will be conducted at the time of the plenary session. <u>A leaflet/questionnaire with the new classification of statistical areas to be implemented from the beginning of 2006 will be circulated on the first day of the plenary session (in October 2004 the Bureau approved a new classification of the statistical areas that is currently being tested for the Integrated Presentation). The Heads of National Statistical Offices will be asked to select those statistical</u>

areas where they believe that the most acute problems with coordination of international statistical work in the UNECE region exist. Attention should also be paid to those statistical areas where insufficient progress is being made or gaps identified.

5. The UNECE secretariat will summarize the information and will make a proposal to the Bureau. The Rapporteurs (countries or international organizations) that will prepare the critical reports will be selected on a case-by-case basis.

6. <u>The new classification of statistical areas is attached in an Annex for information</u>. It is being tested currently as mentioned earlier. As a result of this test, the classification has been slightly modified as compared to the classification that was agreed by the CES Bureau in October 2004.
