# PROGRAMME OF WORK OF THE STATISTICS SUBPROGRAMME FOR 2018-2019


Note by the Secretariat

The note sets out the programme of work of the UNECE subprogramme for 2018-2019 in line with the Strategic Framework for 2018-2019, adopted by the Conference of European Statisticians in April 2016.

The Bureau reviewed and adopted the document. The final programme will be sent to the Conference of European Statisticians for adoption in June 2017 and for recommending it to the Economic Commission for Europe Executive Committee for formal approval.

### I. Introduction

- 1. The present document sets out the programme of work of the Statistics subprogramme ("the subprogramme") of the United Nations Economic Commission for Europe (UNECE) for 2018-2019. The Bureau of the Conference of European Statisticians (CES) is invited to adopt the report and recommend it to the CES plenary session for adoption and to the UNECE Executive Committee (Excom) for approval. Any subsequent additional, discontinued or carried over outputs will be reflected in the Integrated Monitoring and Document Information System (IMDIS) used by the Secretariat for the planning, monitoring and reporting on the implementation of the programme. The results of the implementation of the programme of work will be submitted to the Conference and its Bureau in the Programme Performance report for the biennium 2018-2019.
- 2. The programme of work applies a results-based management (RBM) approach, a broad management approach which establishes logical relationships between the hierarchical results (outputs outcomes impact) known as 'results chain', the resources (human and financial) known as 'inputs' and the external factors (strategic, governance, operational, financial) which can prevent from achieving the objective.
- 3. The outputs/activities in the programme of work correspond to those contained in the ECE proposed programme budget for 2018-2019. They fall into the following main categories: (a) meetings and related parliamentary documentation; (b) other substantive activities; and (c) technical cooperation, including advisory services, training courses, seminars, workshops, and field projects.



- 4. The outcomes/expected accomplishments, with corresponding indicators of achievement and performance measures are presented in Annex I in the form of a logical framework.
- 5. The details of the proposed publications are provided in Annex II. The overall ECE legislative mandates and those specific for the subprogramme are listed in Annex III.

# II. Objective, strategy and external factors

- 6. The objective of the subprogramme is to develop official statistics at the national and international levels for evidence-based policymaking and assessing progress towards Sustainable Development Goals (SDGs), and to ensure the coordination of statistical activities in the ECE region under the Conference of European Statisticians.
- 7. The responsibility for the subprogramme is vested in the Statistical Division.
- 8. The subprogramme will coordinate international statistical activities through the Conference of European Statisticians, joint expert meetings and working groups to share good practices and expertise in official statistics. The subprogramme will ensure effective collaboration and efficient use of resources through close partnerships among national and international statistical organizations.
- 9. The subprogramme will develop standards and recommendations in priority areas identified by the ECE member States, with a focus on supporting the monitoring of progress towards SDGs and the implementation of the 2030 Agenda for Sustainable Development; measurement of climate change; globalization; population, poverty and inequality; and modernization of statistical production, including the use of geospatial information. Work will be undertaken in close cooperation with experts from ECE member States and international organizations through expert groups, each of them developing methodological and practical guidelines to address a specific gap or a challenge in official statistics.
- 10. The subprogramme will support statistical capacity building of ECE member States, particularly of those with less developed statistical systems. It will promote the implementation of the Fundamental Principles of Official Statistics and other United Nations standards and best practices, and provide advice on legal and institutional frameworks of official statistics. This work will be demand-driven and address national priorities identified through global assessments of national statistical systems. It will focus on modernizing statistical production, population censuses, SDG indicators, gender-disaggregated statistics, economic statistics, environmental accounting and indicators.
- 11. The subprogramme will collect and disseminate key socio-economic statistics of ECE member States, including on progress towards the achievement of SDGs and gender equality. The subprogramme will promote the use of these statistics and make them accessible to the public on the Internet. A specific framework will be applied to ensure the quality, coverage and timeliness of the information.
- 12. The subprogramme is expected to achieve its objective and expected accomplishments on the assumption that: (a) adequate resources are in place for monitoring SDGs and supporting the national statistical offices; (b) budget constraints would not hamper the participation of national statistical offices in international work; (c) national and international statistical organizations' willingness to cooperate remains high; (d) donors' support is available for the modernization of statistical production; (e) national statistical offices continue to carry out development work on key statistical domains; and (f) data for the ECE statistical database are made available by statistical organizations free of charge and in a suitable format.
