"Strengthening the **Stat**istical **Cap**acity of **Central Asian** Countries to Monitor the Progress toward the Millenium Development Goals" (StatCapCA-Project),

financed (mainly) by the UN Development Account, 5<sup>th</sup> Tranche, Project 06/07F in the period April 2006 – March 2007

- 1. The content of the **Project Document** was finally approved on April 11 2006. The three following paragraphs, citations from the Executive Summary of this Project Document, reflect the objectives, focus and budget of the Project.
- 2. The **objective** of the Project is to strengthen the statistical capacity of member countries of the UN Special Programme for the Economies of Central Asia (SPECA) to monitor demographic, social and economic progress toward the implementation of the Millennium Declaration. Beneficiary countries are Azerbaijan, Kazakhstan, Kyrgyzstan, Tajikistan, Turkmenistan, Uzbekistan, and partially Afghanistan.
- 3. The Project will **focus on three statistical areas**, namely (i) population and social conditions, (ii) health status of the population, and (iii) economic development. These areas are critical for the monitoring of the Millenium Development Goals (MDGs). Moreover, they are among the cornerstones of any statistical system. In the specific situation of Central Asian countries, it has been observed that difficulties faced over the past two decades have impacted the ability to produce the required basic statistical information in these areas. There is a need for building the statistical capacity of these countries in the three above listed statistical areas.
- 4. The total **budget** of the Project amounts to US\$385,000 and will be conducted over the years 2006 2008. The Project will be implemented by

- the Statistical Division of the UN Economic Commission for Europe (ECE), in close collaboration with the Statistics Division of the UN Department for Economic and Social Affairs (UNDESA), and the Statistical Division of the UN Economic and Social Commission for Asia and the Pacific (UNESCAP). The Interstate Statistical Committee of the Commonwealth of Independent States (CIS) will be involved as far as possible.
- 5. During the one-year reporting period April 2006 March 2007 five main actions of the Project have been organized. During the forthcoming three months, April June 2007 three more actions will take place. This means that eight out of 12 activities, envisaged for 2006 and 2007, in the Result Based Work Plan, Annex 2 of the Project Document, have been accomplished six months before the end of 2007.
- 6. In **Attachment 1** of this Report the different actions of the Project are presented. **Actions, organized during the Reporting period, are bolded.** Forthcoming activities (after March 2007) have also been enlisted in Attachment 1. Detailed information on them has been presented according to availability. Attachment 1 is based on Attachment 2 in the original Project Document.
- 7. The Training Actions on Population and Housing Censuses (Baku, Dushanbe) have been implemented **in fruitful cooperation with UNFPA**. In Baku the Country Office of UNFPA took care of a substantial part of the local arrangements. Besides the (main) participants from the National Statistical Offices there were also active participants from five Country Offices of UNFPA (Azerbaijan, Kazakhstan, Kyrgyzstan, Tajikistan and Turkmenistan). In the Dushanbe Training Workshop the Country Organizations of Kazakhstan and Tajikistan were represented. Active participation is also expected to take place in the third Training Workshop on this theme in Astana in June 2007.
- 8. **UNESCAP participated as a co-organizer** of the SPECA PWG Meeting on Statistics in Paris in June 2006 and will do so in the forthcoming SPECA PWG Meeting in Geneva in June 2007. UNESCAP helped to identify a specialist to act as its representative and as a resource person both in the seminars in Baku (from the Australian Bureau of Statistics, ABS) and Bishkek (from UNESCAP) as well as a participant, representing UNESCAP in the Dushanbe Workshop. UNESCAP will act as a co-organizer in the first Training Workshop on Non-Observed Economy in Bishkek in April 2007.
- 9. **UNSD** has kindly assisted in the organized activities by financing the travel costs of the above-mentioned specialist from ABS to the Workshop in Baku.
- 10. Also the Swiss Federal Statistical Office, Eurostat and the SNA93 Revision Project Group have kindly provided resource persons to the Training Workshops, arranged by the Project, at their own cost.
- 11. Specialists, managers or directors from the NSOs of Azerbaijan, Kazakhstan, Kyrgyz Republic, Tajikistan and Uzbekistan have taken part in all Training Workshops, organized so far. In the Baku and Dushanbe Workshop we also had participants from the NSO of Georgia and Turkmenistan (UNFPA, not NSO). In the Dushanbe Workshop two specialists also from the Afghan NSO participated. The number of participants from NSOs has usually been two and the number of participants from the hosting country clearly higher than that. CIS-STAT has been invited to the Bishkek and Dushanbe Workshops but has for financial reasons not been able to do so. The Georgian Country Office of UNFPA has made the participation of the Georgian NSO in the Census Workshops financially possible through their active support.

- 13. A side result of the Training Workshop organized in Baku has been an agreement on arranging a National Training Workshop on the preparations of the 2010 Round of Population Censuses in **Turkmenistan.** The cooperation partner here is the Country Office of UNFPA, Turkmenistan, which has agreed to arrange and finance the training of about 15 Census managers and staff members of the National Statistical Office of Turkmenistan. This Workshop is planned to take place in Ashgabat on the 7-12 May 2007 based on the materials produced for the Baku and Dushanbe Workshops and with the participation of three UNECE resource persons.
- 14. Another side result of the Project has been the active participation of specialists representing the Uzbek NSO in all so far arranged workshops, resulting, at least partly, from a letter sent to the Prime Minister of **Uzbekistan** in August 2006. The letter was sent in a situation where neither Uzbek nor Turkmen NSOs had reacted in any way to the Invitation to participate in the PWG meeting on Statistics in Paris in June 2006. After the letter there was a positive response both from the Uzbek Mission and from the State Committee on Statistics of Uzbekistan.
- 15. The National Institute of Statistics and Forecasting of **Turkmenistan** has until the end of the reporting period not participated in any of the organized activities. However, there is optimism that the cooperation, promoted by the UNFPA Country organization, referred to above in Para 11, will bring along a change to the positive. For the Training Workshop on Non-Observed Economy, due to take place in the end of April 2007, there are now two registrations of participants Turkmenistan and a paper submitted from this country.
- 16. The **finances of the Project** are, at least for the moment, in a good state of affairs. The first allotment, 45 % of the total Project finances, has, in practical terms, been used by the end of March 2007. This corresponds well with the quantity of implemented activities. The number of participants and training days and to some extent also resource persons in the Training Workshops has been substantially larger than planned. This has been possible by both a strict policy in using the scarce resources of the Project and by UNECE having contacts making it possible to find cooperation partners, which have been willing also to finance their participation in the Project.
- 17. **The use of the Project funding** is, according to the IMIS Report to be seen in **Attachment 2**, the following: 81.2 % (expenditure in relation to the First Allotment of USD 173.250) and **36.5** % (expenditure in relation to the Total Budget of the Project, USD 385,000)
- 18. The Project is now entering its second year and a new allotment request for the usage of the remaining funds has been transmitted to UN Headquarters. Besides the remaining Training Workshops, PWG meetings

and Evaluation process and possible meeting at the end of the Project, UNECE will prepare a plan of advisory services to be given to national statisticians in the Central Asian sub-region in the three focal fields of the Project.
