Recommendations of the Global Assessment of the National Statistical System of the Kyrgyz Republic in 2011

- Revision of the Law on State Statistics in accordance with the UN Fundamental principles;
- Restructuring the National statistical system for streamlining the statistical production processes;
- Human resources management and training;
- Development of the communication and marketing strategy;
- Access to all administrative data;
- Improvement of statistical products in line with international standards and recommendations.



The National strategy for the Development of Statistics in the Kyrgyz Republic 2012-2020 (Statistical Master Plan)

- Harmonization of legal statistical system
- Methodological and analytical capacity building
- Technological capacity building (ICT)
- Organizational capacity building
- Statistical “intellectual” capacity building
- Capacity building in the dissemination of statistics



Ongoing measures on the Recommendations of the Global Assessment

- Development of new edition of the Law on State Statistics
- Development of new Strategy for the information and technological improvement of the Kyrgyz NatStatCom system
- Implementation of the Resource and Methodological Center of the Kyrgyz NatStatCom on the basis of the Institute of Statistical Research and Training Center
- Improvement of Human Resources management



Legislative base improvement

In accordance with the Legislative Work Plan of the Kyrgyz Republic Government, the amendments and supplements to the Law On State Statistics have been implemented in 2012, in order to clarify some of the fundamental principles of official statistics, particularly the confidentiality principle



Procedures on the normative activities process in the Kyrgyz Republic

- Approval of the concept of a new edition of the Law by the President of the Kyrgyz Republic;
- Conducting of the legal and another scientific expertise of the Draft of the Law;
- Organization of the public discussion (upload the draft of the Law on the NatStatCom and media web-sites, organization of press-conferences and round tables);
- Confirmation of the draft with the state authorities;
- Introduction of the draft by the Government of the Kyrgyz Republic to the Parliament;
- Approval by the Parliament;
- Signing by the President of the Kyrgyz Republic.
