Adolescents and Youth as partners to achieve the Sustainable Development Goals

1st March 2018

Note about the event:

This side-event will be organised by the UN SDG Action Campaign in cooperation with the Office of the UN Secretary-General's Envoy on Youth, the European Youth Forum, several UN Youth Delegates and the Regional UN Issue Based Coalition on Adolescents and Youth. It will discuss and share best practises on how Member States can work together with adolescents and youth as partners on the implementation and monitoring of the Sustainable Development Goals (SDGs), and in specific in the process of drafting Voluntary National Reviews (VNRs), and in their delegations to the High-level Political Forum on Sustainable Development (HLPF).

Background:

Each year, Ministers from all over the world gather in July at the United Nations Headquarters in New York to review the progress made in the achievement of the Sustainable Development Goals at the High Level Political Forum. In 2017, the number of Member States reporting on their progress substantially increased to 43. While several Member States mentioned youth and adolescents as important stakeholders in their official implementation and monitoring processes of the SDGs at the national level, as well as in the presentations of the national voluntary reports, many countries are yet to take this step. The objective of this side-event is therefore two-fold:

Objectives:

- 1. To provide a platform for young advocates who have led their own monitoring and accountability processes inside and outside of formal Government structures, where they can showcase their recommendations for Governments to further increase youth engagement in the SDGs including within the Voluntary National Review process.
- 2. Champion Governments and the processes they have used to meaningfully engage young people in the SDGs, and within their Voluntary National Review process, sharing best practices and key learnings.

Expected outcome:

Given the high interest among Member States to include youth and citizens in their SDG implementation strategies, the UN SDG Action Campaign, the Office of the Secretary-General's Envoy on Youth, Regional UN Issue Based Coalition on Adolescents and Youth, and the European Youth Forum expect the event to boost the inclusion of youth and adolescents in implementation



































and monitoring of the SDGs, including the drafting of VNRs to the HLPF. Concretely, the event will inform governments on best practises and strategies that can be utilized to ensure that youth and citizen voices are represented.
