REVIEW OF OPERATIONAL ACTIVITIES UNDERTAKEN IN 2001

Note by the Executive Secretary

Introduction

- 1. Operational activities have continued to be carried out in the year 2001 in the following areas: early warning and conflict prevention; energy; enterprise development; environment; gender and economy; investment promotion; timber; trade facilitation; transport; and statistics.
- 2. Technical assistance has also been provided to individual countries and country-groupings at their request, as well as within the framework of special sub-regional cooperation programmes (SECI and SPECA) and cooperation agreements (BSEC and CEI).
- 3. This year the report on ECE operational activities is focused on the financial aspects of the technical cooperation/assistance provided by the Commission to member States. The purpose of the report is to identify the real distribution of resources by sector, country grouping and country.
- 4. The annex to the present document contains two tables. Table A.1 gives specific information on the activities of the Regional Advisers. Table A.2 provides a list of workshops, seminars, study tours, training courses and other meetings of an operational nature organized in 2001. These include events organized directly by UNECE and those to which UNECE provided a major contribution or support.

I. FUNDING OF OPERATIONAL ACTIVITIES

A. UNECE REGULAR BUDGET

Sectoral distribution

5. Most of the UNECE operational activities have been funded from the ECE regular budget (Section 21 of the UN Budget). As shown in Table 1, in the past biennium of 2000-2001, more than 50 per cent of the resources allocated to technical cooperation/assistance were spent on the activities associated with the implementation of Subprogramme 6 ("Trade, Industry and Enterprise Development"). These include the expenditure on advisory services (which fall under the category of travel) of five Regional Advisers (Regional Advisers on: Trade Facilitation; Investment Promotion; Gender and Economy; Enterprise Development and SMEs; and Development Issues and Policies), but also on the advisory services provided by UNECE regular staff. The technical cooperation/assistance activities associated with the implementation of Subprogramme 2

("Transport") come second, while those of Subprogramme 1 ("Environment") occupy third place.

6. The above information needs to be further disaggregated to give a more precise picture of the distribution structure. Technical cooperation/assistance activities that fall under Subprogramme: Trade, Industry and Enterprise Development, for example, cover such areas as: trade facilitation; investment promotion; gender and economy; enterprise development and SMEs, and development issues and policies. The share of each of these sub-sets of technical cooperation activities in total expenditure accounts for about 10 per cent on average.

Distribution by sector and country

7. A snap-shop of resource allocation of the UNECE Fund for Technical Cooperation to cover the travel expenses of the Regional Advisers and regular staff, undertaking advisory service missions in the fiscal year 2001, is presented in table 2.

[•] RA missions which are undertaken to other countries to secure support from more advanced countries of the region for technical assistance, in particular fund raising, to be provided to economies in transition. These include consultations with government officials, representatives of international and sub-regional organizations like EU, OSCE, World Bank, EBRD, UNIDO, UNESCO, SECI, CEI etc, acting as discussion leaders at international conferences and presenting information on UNECE activities.

^{8.} As Table 2 indicates, a significant amount, ranging between almost 48 per cent in the case of the Environment and Human Settlements Division and about 28 per cent in the case of the Transport Division, was spent on the missions, which fall under the category "Other" and whose purpose appears relevant to all the UNECE member States. These include, for example, contributions to events organized by OSCE, EU, World Bank, UNDP; fund-raising missions, etc.

- 9. Table 2 also shows the percentage distribution of resources by country and sector. This information, however, should be treated with caution as it hides some objective factors responsible for such significant differences among countries/sectors, like geographical distance and therefore a respective difference in the price of air-tickets. The overall travel cost of five missions to a country in close proximity to Geneva will be equal to the travel cost of one mission to any country of Central Asia. The Annex to this report with the breakdown of the advisory missions may be helpful in this respect. As a result, however, the share of some countries appears larger, although the total number of advisory missions, and hence the volume of services provided, is in reality smaller compared with some other countries of the region.
- 10. At the same time, assuming that technical cooperation/assistance is provided in response to the requests of member States, Table 2 reveals, to some extent, countries' preferences. It is obvious that CIS countries presented in the table are interested in receiving technical assistance in the area of energy and transport, while practically all Central and East European countries are interested in technical assistance in areas relevant to trade, enterprise development and SMEs.

Distribution by sub-region

- 11. UNECE has established close relations with a number of the UNECE sub-regional groupings, which have been framed by formal agreements (Memorandum of Understanding and special agreements have been signed between ECE and BSEC, CEI, SPECA, CIS). ECE was one of the co-founders of SECI and has continuously provided technical assistance to this country grouping, although no formal agreement has ever been signed.
- 12. Table 3 illustrates the allocation of travel expenditure by country sub-grouping and sector in the year 2001. It shows that the technical assistance provided to BSEC and CEI countries, for example, is predominately concentrated on the areas that fall under the ECE mandates in trade, industry and enterprise development, followed by the energy sector. A similar pattern is observed in other sub-regions due to the fact that the activities carried out by five out of ten Regional Advisers fall under the Trade, Industry and Enterprise Development element.

13. The distribution of the travel expenditure of the UNECE Divisions among the sub-regional groupings

reveals another dimension of the ECE technical cooperation/assistance (see table 4). It shows that most of the travel expenditure of the Energy Division was allocated to cover the advisory missions to the member countries of the CIS, followed by the SPECA member States. In the case of the Transport Division, these are the Member States of CIS, followed by the BSEC and then SECI member countries.

14. The distribution of technical assistance by country, as is implied by the distribution of travel expenditure (see Table 5), shows that the Russian Federation received most of the resources provided to the member countries of BSEC, while among the SECI member countries, these were Yugoslavia and Croatia.

B. EXTRA-BUDGETARY RESOURCES

Other UN regular budgetary sources

- 15. In addition to the above, some technical assistance delivered by the UNECE is being financed from other regular UN budgetary sources. This is, first and foremost, related to the resources allocated from the **United Nations Development Account** to SPECA (United Nations Special Programme for the Economies of Central Asia), specifically, to the project "**Rational and Efficient Use of Energy and Water Resources in Central Asia**". The overall amount allocated to this project is US\$1.75 million for the period 2000-2002. During the biennium of 2000-2001, US\$1.086 million was spent on implementing this project.
- 16. Some resources in support of ECE technical cooperation/assistance efforts have been made available by the UNDP, which for the ECE represents an additional extra-budgetary source. Over the past year the UNECE Statistical Division spent approximately US\$ 167,000 out of a total amount of US\$ 615,000 which the UNDP provided to support the project "Human Development Statistics and Social Trends Reporting in Eastern and Central Europe and the CIS" for the period 1998-2002. In 2001 the funds from this project were used primarily to organise an ad hoc seminar in Warsaw on social monitoring and human development reporting for Balkan countries; to develop and establish a Regional Website on Gender Statistics for countries in the ECE Region that is planned inter alia to be used for monitoring the status of women and men in ECE countries; and to conduct two draft studies for the UNDP on the human security situation in Southeast European countries and South Caucasus.
- 17. In 2001, the UNECE Sustainable Energy Division spent US\$ 27,000 of the total funds made available by UNDP.
- 19. Some of the UNECE Divisions, as illustrated by Table 6, were able to mobilize and pool together resources from rather diverse funding sources. To some extent, this success could be explained by the interest of both donors and recipients in particular activities, but also by the high degree of relevance of some technical assistance programmes developed and executed by the ECE to the urgent development priorities of the global community, like the sustainability of energy supplies and/or the overall development process.

Voluntary contributions and other extra-budgetary sources of funding

- 20. In general, extra-budgetary sources are contributing to trust funds that have been set up by the UNECE in accordance with regulations approved by the UN General Assembly. As can be seen from Table 6, a trust fund created for an individual project can be filled up with resources mobilized from a number of sources. The mix of these sources differs from one project to another:
 - Trust Fund for the improvement of the Russian timber sector (funded primarily from Dutch donors)-US\$ 200,000
 - Trust Fund mainly for the support of the participation of delegates from European transition countries in identified workshops and seminars organized in the framework of legal instruments serviced by the ECE secretariat (TFACT, financed in 2001 by Bulgaria, Denmark, European Union, Hungary, Italy, Monaco, Norway and the United Kingdom) – US\$ 260,000
 - Trust Fund for Environmental Performance Reviews (financed in 2001 by France, Germany, Italy and the Netherlands) US\$ 160,000
- 21. The SECI programme, apart from the ECE regular budgetary resources, has been receiving a financial support from the United States of America. In 2000, the USA contribution was US\$ 90,000.
- 22. In addition to these "dedicated" trust funds and projects, small amounts are financed from other extra-budgetary trust funds for the purposes covered by them. It can be estimated that the total amount spent in this way, and dispersed over the various trust fund accounts, does not exceed US\$ 50,000 a year.
- 23. Further detailed analysis is needed for a more precise picture of technical cooperation/assistance by the Commission.

II. DEMAND FOR TECHNICAL ASSISTANCE: ITS STRUCTURE AND POSSIBLE RESPONSES

- 24. The UNECE operational activities continue to be under great demand from economies in transition and especially from the CIS. To satisfy this demand effectively and efficiently within the given resource constraints a better prioritisation of the UNECE technical cooperation/assistance is required.
- 25. The structure of the demand for technical assistance implies a shift in the mix of development priorities of some country-members of the CIS. Among recent requests (Belarus, Russian Federation, and other CIS countries), the emphasis was on the need to create a promotion mechanism to ensure that knowledge of international quality norms, standards and regulations is disseminated among the local producers and that the necessary training, as well as testing and certification, are available.
- 26. Requests for advisory services in trade and transport facilitation, including requests (Yugoslavia, Belarus, South Caucasus and Central Asia) to assist with designing of and mobilizing investors for implementing PPP cross-border infrastructure projects have become more frequent. Other infrastructure project-proposals are related to energy and ICT sectors.

- 27. The industrial restructuring process in economies in transition seems to be affecting their demand structure for technical assistance and cooperation. Depending on the stage of the transition process, some countries are more interested in acquiring technical assistance for furthering the development of the new enterprise sector, including SMEs, while others are more interested in assistance with restructuring of the old large industrial enterprises and recovering industrial regions.
- 28. Demand for assistance in the energy and transport sectors has remained very high, especially among the conflict-affected countries and some of the CIS member States. The UNECE has been trying to assist some of these countries by contributing to the work of such comprehensive organizational structures as the Stability Pact and/or EU/WB donors' meeting on Yugoslavia and SECI. Additional extra-budgetary resources in support of some of these activities from the UNECE member States has reduced the pressure to some degree, but have not completely solved the problem of lack of funding.
- 29. The UNECE follow-up activities to the Millennium Summit have revealed the need to increase and target its technical assistance to the vulnerable social groups in countries in transition, such as women and young adults, whose specific needs have not received an adequate attention by policy-makers, hence resulting in growing poverty incidence among these groups. Technical assistance is needed to the countries in transition, which have been trying to modify their institutional systems to make them more supportive with regard to these groups, thus ensuring that vulnerable groups have access to new income-generating opportunities. This would require some re-focusing of the advisory services provided in the area of Enterprise Development and SMEs, but also the mobilization of expertise, which is not available at the Commission, considering the cross-sectoral nature of the issues of gender and youth.
- 30. The same is true with regard to the social consequences of industrial restructuring. Many countries in transition are in need of both policy advice and capacity building to ensure that barriers to the reallocation of resources and creation of new enterprises are removed, thus ensuring that the economic recovery and growth are generating jobs.
- 31. The information on the distribution of technical cooperation/assistance presented above is far from complete and comprehensive. When considered against a more detailed overview of advisory missions (by purpose and output) contained in the annex to this report, it reveals some shortcomings, which call for improvement. The above review first and foremost reveals the need for prioritisation of the UNECE technical cooperation/assistance. It clearly indicates that these activities need to be made:
 - more coherent in terms of definition and criteria;
 - less diverse in terms of their purpose and nature;
 - better evaluated in terms of their impact on beneficiaries/recipients;.
 - more complementary to achieve an augmentation of their impact;
 - better targeted and focused on the most disadvantaged countries.
- 32. In the light of the above, the UNECE secretariat is proposing that a mechanism be established which would allow priorities to be set for the UNECE technical cooperation/ assistance through a consultation process, ensuring a better match between the recipient countries' needs and the ECE capacity to provide high quality assistance. One of the possible approaches could be a consultation process with ECE subregional country groupings to identify their needs in technical assistance against their development priorities

and the on-board ECE expertise and the funding made available to the Commission to mobilize external expertise.

- 33. This mechanism could also ensure that there is a regular feedback from recipient countries on the quality and impact of the ECE technical assistance delivered to them. This would allow both a prompt response to changing needs and adjustment of on-going activities. Setting up such a mechanism of monitoring and evaluation would require a reallocation of resources and changes in the existing reporting system.
- 34. A part of this mechanism will be a stronger coordination of technical assistance across the UNECE country-groupings and sectors provided by the CUOA.
