## **OVERVIEW OF NATIONAL SUMMARY REPORTS SUBMITTED BY PARTIES AND OTHER STATES**

### **Note by the secretariat**

#### **Introduction**

1. The present document provides an overview of national summary reports submitted within the fourth reporting cycle (2017–2019) by Parties to the UNECE-WHO Regional Office for Europe Protocol on Water and Health and by other States.
2. According to article 7 of the Protocol, Parties should review periodically the progress made in achieving the targets set pursuant to article 6, paragraph 2, of the Protocol and publish an assessment of that progress. Parties should also provide to the secretariat for circulation to the other Parties, a summary report of the data collected and evaluated and the assessment of the progress achieved. The Meeting of the Parties shall evaluate progress in implementing the Protocol on the basis of such summary reports. All Parties submitted their summary reports within the fourth reporting cycle.
3. An increasing number of other States also finds it useful to submit summary reports under the Protocol on a voluntary basis. Within the fourth reporting cycle, seven non-Parties submitted summary reports, providing useful insights into their national situation regarding water, sanitation and health and demonstrating that there are specific benefits of reporting under the Protocol, including the collection of integrated data and the enhancement of inter-sectorial cooperation.
