Re: Communication to the Aarhus Convention Compliance Committee concerning a proposed industrial park in Vlora (Ref. ACCC/C/2005/12)

On 27 April 2005, the secretariat of the Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters (Aarhus Convention) received a communication from an Albanian non-governmental organization, Civil Society Development Center of Vlora, sent on behalf of the Alliance for the Protection of the Gulf of Vlora and addressed to the Compliance Committee of the Convention regarding compliance by Albania with certain provisions of the Convention. The communication was submitted in accordance with the provisions of chapter VI of the annex to decision I/7 of the Meeting of the Parties on the review of compliance.

The communication is concerned with access to information and public participation in decision-making on the proposed industrial park and the power station in Vlore (Albania). The full text of the communication, as well as additional information provided by the Party concerned and the communicant are available on the communication's website <a href="http://www.unece.org/env/pp/compliance/C2005-12/DatasheetC-2005-12v13.06.06.doc">http://www.unece.org/env/pp/compliance/C2005-12v13.06.06.doc</a>. A set of the most relevant documents will be posted to you by regular mail, for your convenience.

In its review of the communication, the Committee took note of the fact that the decision-making processes referred to in it were also subject to procedures of the World Bank and the European Bank for Reconstruction and Development (EBRD).

Given the need to avoid duplication of effort and enhance synergies, the Committee has requested the secretariat to inform the EBRD (as well as the World Bank) that it was considering a communication on the matter and to inquire about the EBRD's involvement in the proposed projects, including whether the issue was being addressed within the Bank's Independent Recourse Mechanism.

The Committee also requested that the correspondence to the two institutions would be copied to the Government of Albania and the institutions would be copied on the correspondence to the Government. In connection with this request, you were copied on the letter of the Committee's Chairperson, Prof. Veit Koester, to the Minister of Environment of Albania dated 12 April 2006.

Considering the above, you are kindly invited to provide any relevant information that, in your opinion, will facilitate the process under the Convention's compliance review mechanism. The Committee intends to resume its deliberations on the communication at its thirteenth meeting (4-6 October 2006). We would, therefore appreciate if you could provide any relevant information by mid-September 2006 if possible.
