Dear Mr. Jeremy Wates,

Please find enclosed the following additional documents for the consideration of the substance of communication ACCC/C/2008/24 at the Committee's twenty-third meeting:

No. 1 - Decision adopted by the Environmental Quality Office on September 24, 2004 saying that no EIA is needed for the modification of General Plan based on a previous decision taken at extraordinary session of EIA Commission held on Sep 23, 2004 (the Commission is a body competent to take pre-screening decisions under EIA legislation).

No. 2 - Decision adopted by the regional authority on the administrative appeal lodged by the Association Senda de Granada Oeste on January 4, 2005, to annul the decision adopted by the Environmental Quality Office (Document no. 1 above), rejecting the appeal as inadmissible. The key reasoning for rejection being that the decision not to conduct an EIA is of procedural nature and therefore it cannot be reviewed it. And besides it does not affect the merits of the decision about the modification of General Plan.

No. 3 (1) - Public notice informing on the beginning of the commenting period for the Modification no. 50 to 2001 Murcia City General Plan. It was published in the Official Journal of Murcia on July 22, 2004. The commenting period is of one month. Deadline is August 22, 2004. It clashed with Summer Holiday Season.

No. 3 (2) - Public notice informing on the beginning of the commenting period for the initial approval of Land Slot Plan ZA-Ed 3. It was published in the Official Journal of Murcia on August 25, 2005. The commenting period is of one month. Deadline is August 25, 2005. It clashed with Summer Holiday Season.

No. 3 (3) - Public notice informing on the beginning of the commenting period for the initial approval of Urbanization Project UA1 of the Land Slot Plan ZA-Ed3. It was published in the Official Journal of Murcia on December 22, 2005. The commenting period is of 20 days. Deadline is January 10, 2006. It clashed with Christmas Holiday Season.
