Re: Communication to the Aarhus Convention Compliance Committee concerning compliance by Denmark with provisions of the Convention in connection with fees for appeals to the Nature and Environment Appeal Board (Ref. ACCC/C/2011/57)

On 26 January 2011, the secretariat of the Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters (Aarhus Convention) received from you the above communication addressed to the Compliance Committee of the Convention. The communication concerns compliance by Denmark with provisions of the Convention in connection with fees for appeals to the Nature and Environment Appeal Board. The communication was submitted in accordance with the provisions of chapter VI of the annex to decision I/7 of the Meeting of the Parties.

The Compliance Committee, having considered the admissibility of the communication at its thirty-first meeting (22-25 February 2011), has on a preliminary basis determined it to be admissible in accordance with paragraph 20 of the annex to decision I/7. A copy of the preliminary determination on admissibility is attached. Please note, however, that the Committee has not reached any conclusions with respect to the compliance issues referred to in the communication.

The Committee has also requested you and the Party concerned to address the following question: *What is the average yearly income in Denmark?* Please provide your answer by 14 August 2011.
