As you may be aware, we have on behalf of the Danish Agriculture & Food Council brought the adoption of the Danish river basin management plans under the Danish Act on Environmental Objectives before the Aarhus Convention Compliance Committee.

In that connection, we have of course stated that we have brought three river basin management plans before the Environmental Board of Appeal.
