Modification Project (MOD) 1994

The license application, including the environmental impact assessment (EIA), and other relevant documents were made available at the Ministry of Public Housing, Spatial Planning and the Environment at The Hague, the town hall and public library of Borssele municipality at Heinkenszand and the provincial government building at Middelburg.

The application and the EIA were also sent to the aforementioned administrative bodies as well as to the **national Ministry of Health and Environment in Belgium.**

Project Optimalisatie Splijtstof (POS) 1996

The draft decision and corresponding documents were made available on the same locations and in the same manner as the license application and the EIA. The draft decision was sent to the applicant, to the administrative bodies concerned, to the EIA Commission, to the advisors, to those who had expressed their views with respect to the EIA pursuant to section 7.23 of the Netherlands' Environmental Management Act and to the **national Ministry of Health and Environment in Belgium.**

Project Optimalisatie Splijtstof 2 (POS2) 2004

The draft decision

On 13 July 2004 the draft decision was published in the Government Gazette, as well as in the Dutch newspapers *De Volkskrant*, *De Provinciale Zeeuwse Courant* and the *Faam/Bevelander*.

The notification was also delivered to users of constructed properties in the surrounding area of the Borssele nuclear power plant. As from 14 July 2004 the draft decision was made available together with the application, the EIA and other relevant documents at the aforementioned locations (library and town hall). The draft decision and the notification were also sent to the administrative bodies concerned and to the **Belgian contact organs**.
