**On the consideration of the application**

The Brest Regional Executive Committee considered your application, received on March 19, 2020, on the issue of providing information related to the construction of the object: “Battery Factory LLC “IPower” with its own natural gas boiler at the address: Brest region, FEZ “Brest”, district area “Airport” 1 launch complex”. Based on the results of the review, we report the following.

Location of the object: “Battery Factory LLC “IPower” with its own natural gas boiler at the address: Brest region, FEZ “Brest” district area “Airport” is determined by the Act on the selection of land plot issued in accordance with Decree of the President of the Republic of Belarus dated December 27, 2007 No. 667 “On the seizure and provision of land plots”.

The permission for the construction of object “Battery Factory LLC “IPower” with its own natural gas boiler house at the address: Brest region, FEZ “Brest” district area “Airport” 1 start-up complex with the installation of off-site engineering networks and communications” was issued by the local executive authority in accordance with the Resolution Of the Council of Ministers of the Republic of Belarus of February 20, 2007 No. 223 “On some measures to improve architectural and construction activities”.

*Reference material: The procedure for issuing and attesting copies of documents relating to the rights and (or) legitimate interests of citizens, including individual entrepreneurs and legal entities, is established by Decree of the Council of Ministers of the Republic of Belarus dated December 30, 2012 No. 1256 “On some issues of issuing and attesting copies of documents relating to the rights and (or) legitimate interests of citizens, including individual entrepreneurs, and legal entities ”(hereinafter - Resolution No. 1256).*

*In accordance with subparagraph 1.1 of paragraph 1 of Resolution No. 1256, legal entities of all forms of ownership, unless otherwise provided by legislative acts, issue copies of documents emanating from them to citizens who apply to them, including individual entrepreneurs, and legal entities (hereinafter — applicant) or their representatives, if such copies are necessary to resolve issues relating to the rights and (or) legal interests of applicants, with the exception of copies of outgoing documents relating to the correspondence of state bodies when exercising the functions entrusted to them by legislation. The application of the applicant (his representative) for the issuance of a copy of the document must contain information confirming that this document includes information directly related to the specific rights and (or) legal interests of the applicant.*

*A legal entity refuses to issue copies of documents if the application (request) does not meet the requirements of the legislation on citizens' appeals or on administrative procedures, as well as Resolution No. 1256.*

In case of disagreement with this answer, you have the right to appeal it in accordance with Article 20 of the Law of the Republic of Belarus dated July 18, 2011 No. 300-3 “On Appeals of Citizens and Legal Entities”.
