## Decision II/1 on reporting requirements

*The Meeting of the Parties,*

*Recalling* article 17, paragraph 2, of the Protocol on Pollutant Release and Transfer Registers, which states, inter alia, that the Meeting of the Parties to the Protocol shall keep under continuous review the implementation and development of the Protocol on the basis of regular reporting by the Parties and, with this purpose in mind, will establish guidelines facilitating reporting by the Parties, taking into account the experience gained under the Convention,

*Also recalling* decision I/5 of the first session of the Meeting of the Parties to the Protocol, through which the Parties established a reporting mechanism to monitor the progress in implementation of the provisions of the Protocol,

*Recognizing* that regular reporting by Parties provides important contextual information which facilitates the assessment of compliance under the Protocol and thereby contributes to the work of the Compliance Committee,

*Believing* that public involvement in the process of reporting is likely to improve the quality and accuracy of reports and to strengthen the credibility of the reporting process,

*Taking into account* the objective of a simple, concise and not excessively burdensome reporting mechanism,

*Noting* that this decision concerns reporting by Parties on how they have implemented the requirements of the Protocol and is distinct from the reporting required under article 7 of the Protocol,

*Considering* that the reporting procedure as set out in decision I/5 should continue to apply for the next reporting cycle,

*Emphasizing* the importance of timely submission of reports,

1. *Notes with appreciation* the implementation reports submitted by more than three quarters of the Parties to the Protocol on Pollutant Release and Transfer Registers to the Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters pursuant to decision I/5;

2. *Welcomes* the synthesis report prepared by the Bureau and the Compliance Committee;

3. *Considers* that these reports provide a valuable overview of the status of implementation of the Protocol, as well as significant trends and challenges, which will help to guide future activities;

### **Timely submission of reports**

4. *Notes* that some Parties that submitted reports did not do so within the deadline indicated in decision I/5;

5. *Reiterates its encouragement* of Parties to start the preparation of national implementation reports in future reporting cycles sufficiently in advance of, and at the latest seven months before, the deadline for submission of the reports to the secretariat set out in decision I/5, with a view of ensuring meaningful public consultation on the reports at the national level;

**Failure to submit reports**

6. *Notes with regret* that Albania, Cyprus and Slovenia, all of which were Parties to the Protocol at the time of the deadline for submission of the implementation reports, failed to submit reports;

7. *Calls upon* those Parties that have not yet submitted their national implementation reports to submit them to the secretariat by 1 October 2014, for subsequent consideration, inter alia, by the Compliance Committee;

**Public Consultation**

8. *Welcomes* the fact that most Parties prepared their reports through a process involving consultations with various governmental agencies as well as civil society;

9. *Requests* each Party to prepare its reports on implementation of the Protocol through a transparent and consultative process involving the public in a timely manner, taking account of specific circumstances pertaining to regional economic integration organizations;

**Guidance on reporting requirements**

10. *Also requests* each Party to submit to the secretariat, in advance of each ordinary session of the Meeting of the Parties so as to arrive no later than five months before the session of the Meeting of the Parties for which it is submitted, a report on:

(a) The necessary legislative, regulatory or other measures that it has taken to implement the provisions of the Protocol;

(b) The practical implementation of these measures at the national or, in the case of regional integration organizations, the regional level, using the format set out in the annex to decision I/5;

11. *Further requests* each Party in advance of each subsequent ordinary session of the Meeting of the Parties to review its report and to prepare and submit to the secretariat new information and, where available, a consolidated national implementation report;

12. *Encourages* Parties, Signatories and other States to submit implementation reports through the electronic reporting application developed by the secretariat, and in accordance with the instructions provided by the secretariat.

13. *Requests* Parties, in addition to online reporting, to submit signed hard copies of the reports to the secretariat by post;

14. *Requests* the secretariat to circulate to all Parties and relevant stakeholders a formal reminder of the reporting requirements, including guidance on the preparation of the reports as well as the proposed timing and confirmation of the date for the submission of the reports, to the secretariat in accordance with decision I/5, at least one year in advance of the next session of the Meeting of the Parties;

15. *Invites* Signatories and other States not Party to the Protocol, pending their ratification or accession, to submit reports on measures taken to apply the Protocol in accordance with the aforementioned procedures;

16. *Invites* international, regional and non-governmental organizations engaged in programmes or activities providing support to Parties and/or other States in the implementation of the Protocol to provide the secretariat with reports on their programmes or activities and lessons learned, as well as on implementation of the Protocol itself;

17. *Requests* the secretariat to prepare a synthesis report for each ordinary session of the Meeting of the Parties summarizing the national implementation reports submitted by the Parties and identifying significant trends, challenges and solutions, and to circulate it to the Parties and other stakeholders in due time for its consideration by the Meeting of the Parties to the Protocol;

#### **Translation of the reports**

18. *Decides* to discontinue the decision to process the reports as official documents in the three official languages of the United Nations Economic Commission for Europe (ECE), and requests the secretariat to make the reports available in the languages in which they are submitted, and to make the synthesis report available in the three ECE official languages;

19. *Encourages* Parties that are in a position to do so to provide voluntary translations of the reports in the other two ECE languages. Those Parties that do so are invited to provide the translations preferably not later than one month after the original submission deadline;

20. *Requests* the secretariat to make any unofficial translations of the reports available online.

### **Decision II/2 on the strategic plan for 2015–2020 for the Protocol on Pollutant Release and Transfer Registers**

*The Meeting of the Parties,*

*Recalling* the preamble of the Protocol on Pollutant Release and Transfer Registers, which affirms the wish of the Parties to provide a mechanism contributing to the ability of every person of present and future generations to live in an environment adequate to his or her health and well-being, by ensuring the development of publicly accessible environmental information systems,

*Also recalling* decision I/6 adopted by the Protocol's Meeting of the Parties at its first session (Geneva, 20–22 April 2010), mandating the Working Group of the Parties to the Protocol to consider the need for developing a strategic plan and to take steps to prepare a draft for eventual adoption by the Meeting of the Parties,

1. *Adopts* the strategic plan for 2015–2020 set out in the annex to this decision;
2. *Agrees* that the plan will guide the implementation and further development of the Protocol up until the fourth session of the Meeting of the Parties.

#### **Annex Strategic plan for 2015–2020**

### **I. Introduction**

1. The Protocol on Pollutant Release and Transfer Registers (Protocol on PRTRs) to the Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters (Aarhus Convention) is the first legally binding international instrument on pollutant release and transfer registers (PRTRs). Adopted in 2003, it entered into force in 2009 and has been ratified by 32 Parties so far. It is open for accession by any United Nations Member State, including those outside the un Economic Commission for Europe (ECE) region. The objective of the Protocol on PRTRs is to

enhance public access to information through the establishment of coherent, nationwide PRTRs.

2. By establishing publicly accessible national PRTRs and requiring companies to produce annual reports on their releases and transfers of specified pollutants or transfers of waste, the Protocol on PRTRs aims to contribute to the prevention and reduction of pollution of the environment, thereby contributing to sustainable development and the promotion of green economies.

3. According to its mandate from the Meeting of the Parties to the Protocol to consider the need for developing a strategic plan, and to take steps to prepare a draft for eventual adoption by the Meeting of the Parties (ECE/MP.PRTR/2010/2/Add.1, decisions I/6, para. 9), at its first session the Working Group of the Parties to the Protocol (Geneva, 28–29 November 2011) considered the challenges faced by many countries in ratifying, acceding to or implementing the Protocol; medium- to long-term new development areas of the Protocol; and opportunities to further cooperate and look for synergies with other organizations and multilateral environmental agreements (MEAs), since they share similar objectives as regards protection of the environment and access to information.

4. As a result, the Working Group of the Parties decided to develop a strategic plan for the Protocol for 2015–2020 with a view to its submission to the Meeting of the Parties for consideration and adoption at its second session in 2014.

## II. Vision and mission

5. Our long-term vision is:<sup>1</sup>

(a) To contribute towards ensuring the right of every person of present and future generations to a healthy community through easy, user-friendly and free publicly accessible information about pollution of the environment by means of PRTRs;

(b) To contribute to the prevention and reduction of pollution of the environment by increasing transparency and encouraging improvements in environmental performance by industrial operators in order to move towards sustainable and environmentally sound development.

6. We see it as our mission:

(a) To work towards full implementation of the Protocol on PRTRs by each Party to the Protocol;

(b) To raise the impact of the Protocol by increasing the number of Parties within the ECE region and by encouraging States outside the region to accede to the Protocol or to apply its principles and provisions;

(c) To keep the principles and provisions of the Protocol under continuous review and, as appropriate, consider further development of the Protocol to ensure that it continues to serve as an adequate instrument to achieve its objectives.

### III. Focal areas and goals

7. Focal areas include a set of indicators and targets that will enable the Protocol's Meeting of the Parties and its Working Group of the Parties to assess progress in the implementing the strategic plan.

#### **Focal area I**

##### **Implementation of the Protocol by each Party**

8. To achieve implementation of the Protocol by each Party, Parties, supported by the Protocol bodies, will implement the following objectives:

(a) Data is collected through integrated and preferably electronic reporting tool(s) and is made available through an electronic database, thereby facilitating the use of this data for multiple purposes and the sharing of information according to shared environmental information system (SEIS) principles to be developed throughout the ECE region;<sup>2</sup>

(b) Calculation methodologies for the preparation of data for PRTR reporting, which could be easily adapted and used in all countries, are collected and widely disseminated;

(c) Improve access to information in the PRTR electronic database(s) through a free, dedicated, user-friendly website with links to other websites and databases on subject matters relating to environmental protection;

(d) Ensure that grounds for confidentiality are applied strictly in accordance with article 12 of the Protocol and that, where applied, they can be justified;

(e) Data is made available using geographical information systems (GIS);

(f) Information on releases from diffuse sources is made available, where possible.

#### **Focal area II**

##### **Lifting barriers to ratification and expansion beyond the ECE region**

9. In order to lift barriers to ratification of the Protocol and to expand the Protocol's reach beyond the ECE region, Parties, supported by the Protocol bodies, agree it is desirable to work towards implementing the following objectives:

(a) To examine challenges faced by ECE States on their way to ratification through international cooperation, including translation of relevant guidance material;

(b) To promote and facilitate accession by non-ECE States through international cooperation;

(c) To promote synergies with international organizations through, e.g., the International PRTR Coordinating Group;<sup>3</sup>

(d) To promote synergies with ECE and global MEAs.

### **Focal area III**

#### **Development of the Protocol**

10. To achieve development of the Protocol, Parties, supported by the Protocol bodies, will endeavour to implement the following objectives:

(a) In line with the Protocol's article 6, paragraph 2, and using experience gained from the development of national PRTRs and the implementation of the Protocol, as well as taking into account relevant international processes, identify areas for possible future improvements in annexes I and II to the Protocol;

(b) Inclusion of specific requirements for releases of pollutants from diffuse sources where and when necessary (art. 7, para. 7);

(c) Considering the inclusion of other aspects, such as information on energy and water consumption, on-site transfers of waste or storage (art. 6, para. 2);

(d) Use of the Protocol on PRTRs as a tool for assessing the development of a green economy in the context of sustainable development.

## **IV. Roles and responsibilities**

11. Parties should play a proactive role in promoting and facilitating the implementation of the strategic plan in their countries and in multilateral processes under the Protocol and, where opportunities arise, the Convention. They should assess and regularly follow up on the plan's implementation at all levels of governance. Parties should include all relevant public authorities at the national, regional and local levels (e.g., those responsible for environment, justice, water, agriculture, transport, industry, health, education and foreign issues). Parties should play an important role in the implementation of the Protocol through the channelling of information, coordinating and/or organizing activities, motivating important target groups and monitoring implementation.

12. Stakeholders — including members of the general public, civil society organizations, experts from the education and scientific sectors, the health sector, industry, transport and agriculture sectors, the private sector, trade and labour unions, the mass media, various national, regional and local communities and international organizations — are encouraged to play an active role by supporting implementation of the strategic plan. Civil society organizations, and in particular those promoting environmental protection, have an important role in implementation in alerting the public to its rights and in supporting Governments to understand and to act upon their obligations under the Protocol. International organizations will be invited to support implementation of the strategic plan.

13. The Protocol secretariat will facilitate the implementation of the strategic plan by servicing the Protocol's bodies, organizing regional and subregional capacity-building activities and undertaking advisory and promotional work.

## **Decision II/3 on the work programme for 2015–2017 for the Protocol on Pollutant Release and Transfer Registers**

*The Meeting of the Parties,*

*Recalling* article 17, paragraph 2, of the Protocol on Pollutant Release and Transfer Registers, which requires Parties to keep under continuous review the implementation and development of the Protocol, and with this purpose in mind, inter alia, to establish a programme of work,

*Recalling* its decision I/6 on procedures for the preparation, adoption and monitoring of work programmes and on the work programme for 2011–2014,

*Taking into account* the strategic plan for 2015–2020 of the Protocol on Pollutant Release and Transfer Registers adopted through decision II/2 and the scheme of financial arrangements adopted through decision II/4,

1. *Adopts* the work programme for 2015–2017, containing the estimated costs of each activity, as set out in the annex to this decision;
2. *Agrees* upon the indicative allocation of resources and the resulting estimated costs set out in the annex, subject to annual review and, as appropriate, revision by the Working Group of the Parties on the basis of annual reports provided by the secretariat pursuant to decision II/4 on financial arrangements;
3. *Encourages* Parties to endeavour to ensure that the funding of the activities of the work programme remains stable throughout the period 2015–2017;
4. *Also encourages* Parties, insofar as possible, and subject to the internal budgetary procedures of the Parties, to contribute to the Protocol's trust fund for a given calendar year by 1 October of the preceding year, so as to secure staff costs for the smooth functioning of the secretariat, as a priority, and the timely and effective implementation of the priority activities of the work programme for 2015–2017;
5. *Requests* the Bureau and the Working Group to keep under review the activities of the work programme for the period 2015–2017, and to report and make appropriate recommendations to the Meeting of the Parties at its third ordinary session;
6. *Calls upon* the Parties and invites Signatories, other States and relevant intergovernmental, regional and non-governmental organizations to contribute actively to the activities contained in the work programme;
7. *Requests* the secretariat, taking into consideration the results of the implementation of the work programme for 2015–2017, to prepare a draft work programme for the intersessional period following the third session of the Meeting of the Parties, including a detailed breakdown of estimated costs, for consideration and further elaboration by the Bureau and the Working Group of the Parties, at the latest three months before the third session of the Meeting of the Parties, with a view to possible adoption at that meeting.

## Decision II/4 on financial arrangements under the Protocol on Pollutant Release and Transfer Registers

### *The Meeting of the Parties*

*Recalling* article 17, paragraph 2 (h) of the Protocol on Pollutant Release and Transfer Registers (Protocol on PRTRs) to the Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters (Aarhus Convention), which states that the Meeting of the Parties may consider establishing financial arrangements on a consensus basis to facilitate the implementation of the Protocol,

*Also recalling* decision I/3 of the Meeting of the Parties to the Protocol, establishing an interim voluntary scheme of contributions to be sustained by contributions from Parties, Signatories and other States having opted to participate in the scheme,

*Recognizing* the need to:

- (a) Ensure that sufficient resources are available for implementing the Protocol's work programme for 2015–2017;
- (b) Establish a scheme of financial contributions that is transparent and accessible to all Parties, Signatories and other States and organizations wishing to contribute;
- (c) Establish financial arrangements under the Protocol based on the principles of an equitable sharing of the burden, stable and predictable sources of funding, accountability and sound financial management,

*Believing also* that some organizations and non-State entities, such as charitable foundations, may be interested in contributing financially to the activities under the Protocol's work programme and should be encouraged to do so,

*Noting with regret* that the amounts contributed under the interim voluntary scheme have fallen short of the estimated costs of implementing the work programme for 2011–2014, and that the financial burden has not been evenly distributed, with a significant number of Parties and Signatories not contributing at all,

*Believing* that the financial arrangements in place under the Protocol will need to be kept under periodic review by the Meeting of the Parties to ensure that they continue to meet the goals of stability, predictability and an equitable sharing of the burden,

1. *Decides* to continue maintaining the interim voluntary scheme of contributions as reflected in decision I/3 of the Meeting of the Parties to the Protocol (see ECE/MP.PRTR/2010/2/Add.1);

2. *Also decides* that the interim voluntary scheme of contributions, aimed at covering the costs of activities under the work programme that are not covered by the United Nations regular budget, shall be based on the following principles:

- (a) The Parties shall collectively ensure that the costs of the activities of the work programme that are not covered by the United Nations regular budget are covered through an effective scheme of contributions;
- (b) No Party or Signatory is expected to contribute less than 500 United States dollars to the Protocol's work programme for a given calendar year;

(c) Contributions shall be made in cash and shall not be earmarked for a particular activity;

(d) Additional contributions may be made in cash or in kind, and may be earmarked for a particular activity;

(e) Contributions in cash shall be made through the United Nations Economic Commission for Europe trust fund for local technical cooperation (Aarhus Convention/Protocol on PRTRs project);

(f) Insofar as possible, and subject to the internal budgetary procedures of the Parties, contributions for a given calendar year should preferably be made by 1 October of the preceding year, so as to secure payment of staff costs for the smooth functioning of the secretariat, as a priority, and the timely and effective implementation of the priority activities of the respective programme of work;

(g) Parties pledge, where possible prior to the adoption of a work programme by the Meeting of the Parties, their expected annual or multi-annual financial and in-kind contributions. Signatories, other interested States and organizations may wish to indicate their expected contributions as well;

3. *Requests* Parties, to contribute each year or to make multi-annual contributions towards the costs of activities under the work programme, in accordance with the scheme referred to in paragraph 1;

4. *Invites* Signatories, other interested States and public entities as well as the private sector, in accordance with the 2009 Revised Guidelines on Cooperation between the United Nations and the Business Sector,<sup>4</sup> to contribute, in cash or in kind, towards covering the costs of the work programme;

5. *Calls upon* countries with economies in transition to finance to the extent possible their own participation in the activities;

6. *Calls upon* international organizations working in countries with economies in transition to support participation of representatives of these countries and non-governmental organizations in the meetings and other activities under the Protocol;

7. *Encourages* Parties that have historically contributed generously to maintain their previous levels of contribution;

8. *Also encourages* Parties that have so far not contributed, or have contributed modestly, to increase their contributions during the current and future budget cycles so as to ensure the equitable distribution of the financial responsibility for implementation of the work programme, and requests the Bureau to liaise with such Parties where appropriate concerning the achievement of this goal;

9. *Requests* the secretariat, in accordance with the financial rules of the United Nations, to allocate in the Convention trust fund by 1 October of each year the sum required for the extension of the contracts of extrabudgetary staff of the secretariat for the upcoming year, as a priority, and also the costs needed for implementation of activities in the first quarter of the upcoming year;

10. *Also requests* the secretariat, in accordance with the financial rules of the United Nations, to monitor the expenditure of the funds and to prepare annual reports for review by the Working Group of the Parties in order to ensure that the level of

contributions matches the level of funding needed for the implementation of the work programme;

11. *Requests* the Working Group of the Parties to consider, in the light of these annual reports, whether changes would be required to the content or time frame of the work programme, in the event that the level of actual and/or pledged contributions does not match the level of funding needed;

12. *Further requests* the secretariat to prepare a comprehensive financial report for each session of the Meeting of the Parties, including information on how much Parties and other participating States and organizations have contributed to the budget of the Protocol in cash and in kind, and on how the contributions were spent;

13. *Mandates* the Bureau and the Working Group of the Parties to explore in the next intersessional period options for more predictable, stable and equitably shared funding and requests them to make the appropriate proposals for the consideration of the Meeting of the Parties at its third session;

14. *Requests* the United Nations Economic Commission for Europe to allocate more resources to support the work under the Convention and its Protocol considering, inter alia, the balance in the use of regular budgetary resources in the different subprogrammes;

15. *Agrees* to review the operation of the scheme of financial arrangements at the third session of the Meeting of the Parties.
