ITC and rural public information centres

The UNECE Team of Experts on Internet Enterprise Development (TSIED) contributed to the organization of an international conference on the use of Information and Communication Technologies (ICTs) at rural Public Information

Centres (PICs). The conference, held at Bishkek, Kyrgyzstan, on 16-17 August, discussed mainly the regulatory framework and use of the rural PICs for e-government, e-business, and e-education and e-health purposes. Real life examples from UNECE member countries as well as Asia, Africa and Latin America were examined.

The conference further discussed issues on rural connectivity, evaluation of rural PICs projects and the establishment of an International Public Information Access Points Association.

The conference was co-organized by the Information Future Public Foundation, a non-for-profit organization headed by Mr. Nurbek A. Toichubaev, a bureau member of TSIED, the

Ministry of Transport and Communication of the Kyrgyz Republic, UNECE, United Nations Development Programme (UNDP), European Bank for Reconstruction and Development (EBRD), and the Soros Foundation. The Information Future

Public Foundation has already set up over 30 self-sustainable PICs in rural areas in cooperation with the Government of Kyrgyzstan and the private sector.

The TSIED was established in 2000 under the Committee for Trade, Industry and Enterprise Development. It provides a forum for UNECE member States for

discussion on the use of the Internet for enterprise development, and assists in the creation of an enabling environment for e-commerce and Internet-based services development.

Aarhus Clearinghouse

The Aarhus Clearinghouse for Environmental Democracy was launched just over one year ago to promote good practices in support of principle 10 of the Rio Declaration on Environment and Development and the Aarhus Convention. During its first year, the Clearinghouse has attracted more than 130,000 visits. Several thousand visitors now use the site on a regular basis to learn how the principles of the Aarhus Convention are being applied in practice. Last month (July 2005) more than 30,000 visits were made to the Clearinghouse.

The Clearinghouse's *Resource Directory* features 700 information resources on the laws and good practices relevant to the rights of public access to information, public participation in environmental decision-making and access to justice on

environmental issues. *Convention News* keeps Parties and other interested stakeholders informed of the latest developments.

Information gathered through the reporting requirements under the Aarhus Convention is fed into the Clearinghouse by national focal points of the Parties to the Convention. Non-governmental organizations may also submit information to the Clearinghouse through their national focal points or through the Aarhus Secretariat.



Global governance: lessons from Europe

The text of the 2005 Gunnar Myrdal Lecture, delivered by Pascal Lamy, is now available in English and French.

Abstract: "[...] There are five lessons to be learnt. The first lesson teaches us that liberalization involves international cooperation. Like Janus, the globalization that has broken into our daily lives has two faces. One is all smiles and sees liberalization as a virtue and economic, social and cultural exchanges as a source of innovation and an opportunity for dialogue and understanding. The other face is far less becoming: it sees liberalization as a threat directed first at the weakest, as an irresistible pressure that destroys all identity and as an iron law of unbridled market capitalism. The free circulation of goods, services, capital and persons is nothing, then, but an unacknowledged war between national entities, multinational corporations and even civilizations. The free interplay of comparative advantage in the economic field, so dear to Gunnar Myrdal, can be but an illusion so long as norms, standards and regulations adopted by national authorities have a distorting effect on trade ...".


