#### Opening session

#### H.E. Sen. Antonio GENTILE,

Undersecretary of State of the Ministry of Economic Development, President of the Italian Task Force for Smart Cities, Italy



Married, two children. Executive of the National Health Service's ASL in Cosenza since 1980, free-lance journalist, he was elected Senator for the first time in the 2001 general election in the Cosenza constituency, where he stood for the Casa delle Libertà coalition. He has been Secretary of the Treasury and Finance Committee and member of the Parliamentary Enquiry Committee on mafiatype organised crime. He was reelected in the 2006 general election with Forza Italia in Calabria, and has been reconfirmed for a third mandate in the following election in 2008, where he stood for the Popolo delle Libertà. On 5 May 2011 he was appointed Undersecretary of State at the Ministry of the Economy in the Berlusconi IV Cabinet. He was reelected in the 2013 general election and was appointed Secretary of the Senate for the Popolo delle Libertà. On 16 November 2013, following the suspension of the activities of the Popolo delle Libertà party and the relaunch of Forza Italia, he joined the Nuovo Centrodestra party led by Angelino Alfano, for which he became Regional Coordinator for Calabria. He is a member of the Parliamentary Committee for Childhood and Adolescence. In February 2016 he was appointed Undersecretary of State at the Ministry of Economic Development.





On 9 July 2014, the Secretary-General appointed Mr. Christian Friis Bach of Denmark as the next Executive Secretary of UNECE. Mr. Bach brings to the position a combination of deep knowledge in international economy and development affairs coupled with innovative and results-oriented leadership. Mr Bach came from a position as Member of the Danish Parliament and Head of the Parliamentarian Group for the Danish Social/Liberal Party. He previously served as Denmark's Minister for Development Cooperation (2011-2013) and Special Advisor to the European Union Commission for the United Nations Global Sustainability Panel (2010-2011). He is Honorary Professor of International Economics and Development at the University of Copenhagen (2009-2014) and has been Associate Professor in International Economics and Development Economics, the Royal Veterinary and Agricultural University (1999-2005). Mr. Bach has a long history with civil society, notably as the International Director for the DanChurchAid (2005-2010) and as Chairman of the Danish Association for International Cooperation (1997-2001). He also has private sector experience from running a start-up company and has worked as a journalist at the Danish Broadcasting Corporation. Mr. Bach holds a Ph.D. in International Economics

(1996), an MSc in Agronomy (1992) from the Royal Danish Agricultural University in Copenhagen and a supplementary degree in Journalism from the Danish School of Media and Journalism. Born in 1966, Mr. Bach is married and has three

children. The family lives on a small farm outside of Copenhagen.

#### Malcolm JONHSON

Deputy Secretary General, ITU



From 2007 to 2014, he served as Director of ITU's Telecommunication Standardization Bureau (TSB). In this post, he spearheaded activities in cybersecurity, climate change and accessibility. He increased the involvement of developing countries and academia in ITU's standards activities, introduced free downloading of ITU-T Recommendations, and initiated a programme to address developing-country concerns over lack of interoperability and conformity to ITU standards. He achieved a threefold increase in the activities of ITU's Telecommunication Standardization Sector without increasing its budget. Between 2003 and 2006, Mr Johnson was International Coordinator at the United Kingdom's Office of Communications (Ofcom), where he had lead responsibility for the United Kingdom in ITU and in CEPT. From 1992 to 2003, he was Director of United Kingdom's Radiocommunications Agency and European Coordinator for WRC-93, WRC-95 and WRC-97. Between 1988 and 1992, he worked in the European Commission's Telecommunication Regulations Division, where he represented the Commission in the Council of the European Union, EU Parliament, CEPT and ITU. Born in Trallwng, Wales, United Kingdom, Mr Johnson graduated from the University of Wales, Cardiff, with MSc and BSc (1st class honours) degrees in 1976. He is a Chartered Engineer, a Fellow of the Institution of Engineering and Technology, an Honorary Professor of Amity University and an Academician of the International Telecommunication Academy. He is fluent in English and French, and has some knowledge of Spanish.


#### Mario BOZZO
