In total more than 50 representatives participated in the meeting, including 6 high-level participants from Afghanistan. Main Activity A.2 Hydrology meetings and a mechanism for data exchange	 The annual meeting endorsed: a "Memorandum of Understanding on exchange of hydrological data and information relating to the Panj-Amu Darya river basin between the state authorities of the Islamic Republic of Afghanistan and the Republic of Tajikistan for the period of 2015-2017 and prospectively until 2020", and "Terms of Reference of the Technical Working Group on hydrological monitoring". For the preparation of these documents as well as the annual meeting two expeditions were organized during autumn 2014.

Main Activity A.3 Joint expeditions and training, afforestation	During the annual meeting the document "Programme of cooperation between Afghanistan and Tajikistan, 2015-2017 (and prospectively to 2020), on the environment in the Amu Darya/Panj river basin" was discussed as a

support	basis for future cooperation. The possibility to establish a separate bilateral environmental agreement was also discussed.
	For the preparation of the environmental bilateral cooperation two expeditions were organized during autumn 2014.

COMMENTS

The main problems in the execution of the project are the political and security situation in Afghanistan is a bottleneck for a sustained active dialogue between institutions in the countries. The political culture in Afghanistan also makes decision-making difficult – for example on implementation of items in an agreed work programme.
