## **TERMS OF REFERENCE**

1. Objectives and Targets (Specific Functions of Consultant/Individual Contractor)

At the 2013 High-level seminar on Population Censuses and Migration Statistics in Gelendzhik, Russian Federation, it was agreed in 2015 to produce a manual on the use of administrative data and sample surveys to measure international migration in the CIS region. The guide will be reviewed by experts from CIS countries at a 2015 workshop in Belarus and then presented to the Conference of European Statisticians for final approval. The guide will consist of 4 chapters, totaling about 100 pages. The majority of written material will be produced for chapters 2 and 3 of the manual on the use of administrative data and sample surveys to measure migration.

The objective of this consultancy is to produce Chapter 2 of the manual, on the use of administrative data to measure migration. The chapter will need to provide an overview of sources and issues with the use of administrative data in the CIS region, discuss current and future implementation of population registers, border control data, visa and residence permits and other administrative sources, and their ability to produce migration statistics. It will also discuss the advantages and disadvantages of these data systems, data quality issues, context specific to the CIS-region on the use of administrative sources, as well as methods of improving communication between the producers of administrative data and national statistical offices. Additional topics related to administrative data issues could also be included and it should draw from regional and international examples as needed. It should also include recommendations on how administrative systems could be better utilized or developed to improve the measurement of migration.
