### MEMORANDUM OF UNDERSTANDING

## **BETWEEN**

## THE UNITED NATIONS ECONOMIC COMMISSION FOR EUROPE

## AND

## **IESE BUSINESS SCHOOL (University of Navarra)**

The **United Nations Economic Commission for Europe** (hereinafter referred to as "UNECE"), as represented by the Leslie Cleland, Executive Officer

and

The **IESE Business School**, **University of Navarra**, **Spain** (hereinafter referred to as "IESE"), as represented by the Jaime Alonso Stuyck, General Administrator

hereinafter referred to as the "Parties",

- **RECOGNIZING** the desire of the Parties to establish and develop cooperation to promote the UNECE Public-Private Partnerships (PPPs) Initiative and in particular the UNECE International PPP Centre of Excellence as a tool for social and economic development,
- TAKING INTO ACCOUNT the desire of the Parties to establish an appropriate mechanism for such cooperation,

### hereby agree to the following:

### Article 1

- (1) The Parties agree to cooperate and promote the overall UNECE PPP Initiative, inter
  - (a) the goals and objectives of the UNECE International PPP Centre of Excellence (hereinafter referred to as "ICoE") in Geneva, Switzerland an integral part of the UNECE secretariat;
  - (b) the creation of the International Specialist Centre of Excellence on PPPs in Smart and Sustainable Cities (hereinafter referred to as "Centre") in Spain;
  - (c) the development of international PPP best practice guides on PPPs in Smart and Sustainable Cities; and
  - (d) other areas of common interest.
- (2) Within the framework of the Memorandum of Understanding (hereinafter referred to as the "Memorandum"), the Parties will be guided by the general principles and standards of international law and shall cooperate in accordance with the principles of equity, transparency and reciprocity.

(3) The Parties will work together towards the implementation of the provisions of this Memorandum through their authorized representatives, as designated by the Parties, in addressing emerging issues and initiating joint activities.

#### Article 2

- (1) The IESE shall:
  - (a) provide the UNECE funds amounting to US\$60,000 in one installment in extrabudgetary resources pursuant to Article 4 towards the PPP work undertaken by the ICoE;
  - (b) set up, manage and finance for the duration of the Memorandum the Centre as an integral part of the IESE and operating in accordance with the rules and regulations of IESE, and working towards the goals and objectives, and under the guidance of, the ICoE, as specified in Part A of Annex 1;
  - (c) under the direction of the UNECE, identify international PPP best-practice models in PPP smart and sustainable cities, as specified in Part B of Annex 1;
  - (d) translate from English to Spanish PPP standards developed by the UNECE ICoE and a PPP training module (introduction to PPPs) not exceeding 200 pages per year;
  - (e) coordinate with and assist the UNECE in promoting the overall goals and objectives of the UNECE ICoE, including:
    - (i) organize, host and fund regular symposiums, workshops, training programmes and seminars in PPP smart and sustainable cities, including an international conference to inaugurate the Centre in Barcelona in 2015; and
    - (ii) develop and produce print and audio-visual materials related to the Centre, including marketing materials.
- (f) following the commencement of full operations of the Centre, it shall report to the UNECE on the overall performance of the Centre. Reporting activities shall include, inter alia:
  - (i) the number of new members and number of governments that received assistance from the Centre;
  - (ii) the number of seminars, workshops, training programmes, conferences and other similar activities held;
  - (iii) statistics on website traffic and downloads of the international PPP best practice models in Smart and Sustainable Cities;
  - (iv) the number of new case studies added to the PPP best practice models in the Smart and Sustainable Cities sector;
  - (v) update of the PPP best practice models on PPPs in Smart and Sustainable Cities on a regular basis, and at least on an annual basis; and
  - (vi) any other activity related to the Centre as agreed with UNECE.
- (g) establish and operate a dedicated website for the Centre;

- (h) be entitled to collect and retain revenues derived from a number of activities conducted by the Centre that are not covered by this Memorandum.
- (i) own all intellectual property and in particular copyright in all documentation produced in the deliverables as specified in Part B of Annex 1;
- (j) grant to the UNECE an exclusive royalty-free worldwide license for any use, in all media, of the works referred to in Part B of Annex 1, including such future modification carried out by IESE as may appropriately advance UNECE PPP standards, for the duration of its copyright in all languages. It is expected that the future economic benefit to the UNECE for the use of this license would not exceed USD \$20,000.

## (2) The UNECE shall:

- (a) continue to promote the goals and objectives of the ICoE;
- (b) delegate to IESE on an exclusive basis for the duration of this Memorandum to set up the Specialist Centre on PPPs in Smart and Sustainable Cities and to develop and maintain PPP best practice models in Smart and Sustainable Cities
- (c) guide and oversee Centre's implementation of the deliverables in Part A of Annex 1, including the approval of all activities and standardized processes for the Centre;
- (d) guide and oversee the implementation of the deliverables in Part B of Annex 1, including the approval of the style, format and contents of the PPP best practice models on PPPs in Smart and Sustainable Cities;
- (e) coordinate the interface between the IESE and other participants in the ICoE;
- (f) warrant that, for the duration of the Memorandum, it will not enter into any other agreement or arrangement with any other government or entity to host the Centre on PPPs in Smart and Sustainable Cities; and
- (g) liaise with the Bureau of the UNECE Team of Specialists on Public-Private Partnerships, which provides overall substantive and policy guidance to the ICoE.

## Article 3

- (1) It is expected that operations and services by the Centre commence in February 2015.
- (2) The activities under the Memorandum shall be performed in accordance with the schedule set out in Part C of Annex 1.

#### Article 4

(1) The transfer of funds by the IESE to UNECE amounting to US\$60,000 pursuant to Article 2(1)(a), shall be effected in February 2017. The UNECE's bank details are contained in Annex 3.

- The funds transferred from the IESE to the UNECE for the purpose of the Memorandum shall be exclusively administered and accounted for by the UNECE in accordance with the applicable United Nations financial regulations, rules and directives applicable to technical cooperation trust fund accounts. The contribution is subject exclusively to the internal and external auditing procedures of the United Nations. The UNECE shall reserve the right to reallocate contributions to other activities within the UNECE PPP work.
- (3) The contribution is inclusive of the standard United Nations Programme Support Cost of thirteen (13) per cent.
- (4) All financial accounts and statements shall be expressed in United States dollars. No specific financial or substantive reporting is required, and no return obligation exists and any unused balance and interest income earned will be credited to the fund as an un-earmarked contribution for ongoing activities.

#### Article 5

(1) Any modifications or changes to the present Memorandum shall be made in writing with the consent of both parties, and shall take effect on the date of signature by the parties.

#### Article 6

- (1) The Memorandum is concluded for a period of three (3) years and it shall enter into force upon signature by both parties and shall remain valid until such time as any Party provides a notice of termination to the other Party with a minimum notice period of six (6) months.
- (2) In the event that this Memorandum is terminated in accordance with Article 6(1):
  - (a) the IESE shall provide UNECE with both hard and electronic copies of all documentation, within thirty (30) days of the termination taking effect;
  - (b) the Parties shall fulfill in good faith any aspect of their respective commitments expressly undertaken prior to the termination taking effect. This would include all funds already committed prior to the termination of this agreement; and
  - (c) each Party waives all rights to any further claim for damages.
- (3) Nothing in or relating to the present Memorandum will constitute, nor imply, a waiver from the privileges and immunities enjoyed by the UNECE under the terms of the 1946 Convention on the Privileges and Immunities of the United Nations.

#### Article 7

(1) Each Party shall appoint an authorized representative, who shall at all times have the authority to act on behalf of that Party in respect of this Memorandum. The identity and contact information for each Party's authorized representative are specified in Annex 2.



#### Article 8

- (1) All communication between the Parties in respect to the terms of this Memorandum will only have effect for the purposes of this Memorandum if it is:
  - (a) in writing;
  - (b) in English;
  - (c) signed and dated by the sending Party's authorized representative;
  - (d) clearly marked for the attention of the receiving Party's appointed Representative; and
  - (e) delivered by any means as reasonably specified by the intended recipient, including by mail, fax and/or email.
- (2) Communications will take effect from the time they are received by the receiving Party's authorized representative, unless a later time is expressly specified in that communication.

#### Article 9

(1) In fulfilling its obligations under this Memorandum, IESE may only use the United Nations logo subject in each instance to the express prior written approval of the UNECE Executive Officer.

#### Article 10

- (1) The Parties agree to seek the resolution of any dispute arising in connection with the application and/or interpretation of the present Memorandum in a spirit of cooperation and good faith, through communication between each Party's authorized representative as identified in Annex 2.
- (2) If a dispute cannot be resolved at the operating level, the subject of disagreement will be recorded in writing by each party and presented to the other party for consideration. If resolution to the dispute is not reached within thirty (30) days, the Parties will forward the written record of the dispute to the executive head of each party for consideration and settlement.

#### ANNEX 1

## PART B: PPP best practice models for smart and sustainable cities

The Specialist Centre of Excellence on PPPs in Smart and Sustainable Cities shall:

- 1. Based on a standard template for the ways to present PPP models provided by the UNECE, identify PPP best practice models in the smart and sustainable cities sector;
- 2. With the assistance of the UNECE, create a body of distinguished experts to advise the Specialist Centre on these models from both public and private sectors including representatives of International Organisations, and the Multilateral Development Banks<sup>1</sup>;
- 3. Look at how these models need to be adapted in countries in a pre PPP stage in their development and develop partnerships with beneficiary countries of the Specialist Centre who are seeking support in developing their own smart and sustainable cities programmes through partnerships;
- **4.** Once this data is collected, organize at least one annual meeting to disseminate these materials;
- 5. Become through the organization of such events a depository of best practice models that can be of specific help to improve PPPs in the smart and sustainable cities sector.

# ANNEX 1 PART C: Schedule

The PPP best practice models in the smart and sustainable cities sector should be developed by the Specialist Centre over a period of 18 months according to the following schedule:

- -by July 2015 , present a draft of the PPP best practice models in the smart and sustainable cities sector based on international PPP experience;
- - by November 2015, prepare a final version of the PPP best practice models in the smart and sustainable cities sector;
- -by July 2015, present a list of potential best practice projects; and
- - by November 20, 5 prepare a final list of best practice projects.
