Dear Anna, dear Ilia,

I am writing to you on behalf of the UNECE/FAO Forestry and Timber Section in my function as project manager with the request for your kind approval of the extension of the deadline for the Russian Funded Project "Support to activities aimed at the implementation of the outcomes of the 72nd session of the Committee on Forests and the Forest Industry in Kazan, Russian Federation related to the Rovaniemi Action Plan." (internal UNECE project Number E241).

The project was approved by the Russian Federation and EXCOM with a deadline of 29 February 2016. However, due to delays in internal financial processing (namely introduction of UMOJA) as well as several changes in the team of the UNECE/FAO Forestry and Timber Section, we have not been able to implement all activities by the deadline provided. The current status is as follows:

Activities A1.3, A1.4 and A1.6 have been successfully been implemented. Activites A1.2 and A1.4 have been started and work is in progress. We also started preparations for A1.1 and would be able to provide contracts for two consultants, soon.

We would be very grateful, if you could grant an extension of the deadline for the above mentioned project until 30 September 2016. This will allow us to fully implement all the above mentioned activities.
