### VI. SUMMARY OF ACHIEVEMENTS TO DATE

During the reporting period six national capacity building workshops have been implemented in Armenia, Georgia, Kazakhstan, Kyrgyzstan, Tajikistan and Uzbekistan in 2014 <sup>1</sup>. Based on the evaluations 89 % of the participants have acknowledged increased knowledge on policy formulation, bioenergy generation and data collection related to sustainable forest management and green economy.

The concept of green economy is rather new for some of the project countries, and several non-pilot countries (Armenia and Uzbekistan) have expressed their interest in similar support in development of the forest sector.

As for pilot countries, Georgia, Kazakhstan and Tajikistan have made substantial progress towards green economy. Georgia is currently developing an action plan based on the input received from four local workshops (conducted in 2014). Government of Kazakhstan officially agreed to review the draft national forest program in order to include green economy principles. As a result, private sector development has gained remarkable role in widening the original scope of the program focused on conservation. The draft national forest programme was scheduled to be approved by national authorities in Kazakhstan by the end of 2014. The draft is currently being reviewed by the ministries and once they have reached agreement for the programme funding, it will proceed to approval by the prime minister and the president. In Tajikistan the project supports development of a new forest strategy implemented jointly by FAO and GIZ. The project has already provided support in the area of private sector development, in particular, by undertaking analysis of the current situation in Tajikistan of private sector.

It will further focus on participatory review of the draft forest strategy (input will be provided in January 2015).

Overall implementation of the project goes smoothly. Turkmenistan, as initially planned, does not participate in the project due to lack of interest. No official commitment to participate in the project was received from Turkmenistan. Proper attention shall be given by the project team to ensuring sustainability and monitoring of the project results after the project terminates. For example Kyrgyzstan has expressed interest to use the project methods in forest policy development, which is planned to start 2015. UNECE-FAO shall offer support in follow-up activities by distributing the project outcome and recommendations with relevant ministries and agencies through official channels. Evaluation of the project is planned to take place during spring 2015, and will include national action plan, forest strategy or programme developed by the pilot countries Georgia, Kazakhstan and Tajikistan, as well as feedback received from participants of the workshops.

## IX.SUPPLEMENTARY FUNDING

Representatives from Armenia, Azerbaijan, Kyrgyzstan, Tajikistan and Uzbekistan were supported by the Russian Federation to participate in the meeting of the UNECE Committee on Forests and the Forest Industry in Kazan, Russian Federation in November 2014.

Activities in Tajikistan were coordinated jointly with GIZ and FAO Tajikistan in order to prepare a joint roadmap of activities to support the new forest policy development and avoid possible overlaps with different actors. It was agreed that the UNDA project's role would look into forest private sector development (December 2014) and stakeholder review of the draft forest strategy in early 2015.

For the final regional workshop, which will bring together all seven project countries in April 2015, we have initiated discussions with EU funded RERAM project (Resource Efficiency and Raw Material Use of Woodworking Industries in Eastern Europe), how to combine our projects activities to benefit participants in both projects by organizing joint activities.

#### X.REVISIONS

Funds (US\$ 24,800) initially allocated for consultants have been re-allotted to be able to bring more meeting participants to the final regional workshop in April 2015, and to support other capacity-building activities, e.g. the national workshop in Azerbaijan.

The original allotment to support meeting participants was not sufficient. To solve this issue it has been decided to develop the web-based hub using existing human resources available at the UNECE-FAO Forestry and Timber Section.

The final regional workshop (Tbilisi, Georgia, 21-24 April 2015) is of utmost importance for success of the project and plays a key role in lessons sharing and knowledge exchange. The request for re-allotment of US\$ has been made in December 2014 (please see details in Table XIII), and it was agreed by the Programme Management in UNECE.
