#### 1. SUMMARY OF ACHIEVEMENTS TO DATE

In 2016, Armenia, Republic of Moldova, Serbia and Tajikistan further developed of the National Action Plans for Sustainable Housing and Urban Development (NAPs) with support of UNECE and UN-Habitat. The project also developed guidelines for drafting the National Action Plan for the implementation of recommendations of UNECE Country Profiles on Housing and Land Management in transition economies on the basis of the Geneva UN Charter on Sustainable Housing. These guidelines will be used for all countries of the ECE region. The guidelines are aimed to assist the governments to organize the work of the institutions, which are supposed to ensure the implementation of the National Action Plan in balanced and sustainable way; to identify and use reserves to improve the efficiency of the implementation of activities in the sphere of housing and land management; to organize interaction between all major stakeholders, including government, businesses, local self-governing authorities, international organizations and foreign donors.

More specifically, the draft NAPs of Republic of Moldova and Serbia were developed based on the guidelines and draft NAPs of Armenia and Tajikistan are being finalized according to the guidelines in 2016. The NAPs will be presented by the countries-participants at the regional workshop in Belgrade, Serbia on 31 January-2 February 2017.

One national validation workshop (Dushanbe, Tajikistan, 26 April 2016) presented and discussed proposals for the NAP by the government. The proposals were based on the policy recommendations of the country profile and other relevant projects and studies, such as Safer Cities Program of the UN-Habitat, Mountain Societies Development Support Program of the Aga Khan Foundation and local activities of the Caritas Switzerland. Representatives of the UNECE shared information on international studies, guidance documents which could be useful for the preparation and later for the implementation of the NAPs. The proposals for the NAPs were discussed by the national and international experts who informed on existing experiences and practices which should be taken into account in the NAPs. As a result of the workshop, the National Action Plan was reviewed and it was agreed to include measures on modernization of the housing stock and infrastructure, monitoring energy efficiency in the buildings, development of architectural design standards and preparation of the Urban Development Strategy and several other activities as per Workshop Resolution available at http://www.unece.org/housing-and-land-management/projects/housingunda/tajikistan.html.

Planning of 2017 activities was completed and dates of 2017 workshops have been agreed.

The NAP focused on establishing a comprehensive framework for the housing policy. The central tool for the future implementation of the NAP is a draft national law on housing which was developed under the NAP and was discussed at the workshop with the stakeholders. In 2016 the NAP was under revision to be redrafted according to the guidelines.  The draft brief National Action Plan for Tajikistan was prepared and the full-text version was in the preparation during 2016. The NAP was focused on promoting energy efficiency of residential buildings and technical control of new construction. Since 2014, Agency of Architecture and Construction was working jointly with the European Bank for Reconstruction and Development on energy efficiency in buildings.  The priorities and main parts of the National Action Plan for Republic of Moldova were discussed at the workshop in 2015. The priorities of the NAP are on management of multi-apartment buildings, especially on the issues of energy efficiency (developing financial mechanisms to promote energy efficiency in multi-apartment buildings). In addition, the NAP is focusing on the implementation of the Government Decentralization Strategy aimed at giving more responsibilities and power to local authorities. It was agreed with the

		government that the NAP will be adopted by the Ministry of Regional development and Construction at the beginning of 2017 and later on by the Government Decision.  The National Action Plan for Armenia is currently being developed based on the recommendation from the draft Country Profile prepared by UNECE and submitted to the Government of Armenia. As discussed with the Government, priorities of the NAP are on spatial planning, municipal management and smart cities.
