1. SUMMARY OF ACHIEVEMENTS TO DATE

In 2016, the UNECE and the UN-Habitat completed the preliminary planning and consultations on the project implementation and agreed on the schedule of activities in 2017. One advisory mission has taken place in Bishkek, Kyrgyzstan on 27-30 April 2016 to identify the needs and priorities of the government in relation to the project. Consultations were undertaken with the representatives of Albania and Georgia. Representatives of Ukraine were not available for the preliminary meeting in Geneva and following it consultations. The representatives of key state authorities have attended the UNDA 9th tranche workshop in Geneva on 16 September 2016 in order to introduce the national coordinators of the UNDA 9th tranche project and exchange of the experience. The workshop ensured linkages between 9th and 10th Tranches projects and enhanced regional cooperation between the countries with economies in transition in the field of sustainable housing, urban development and land management.
