1. Adoption of the agenda

2. Matters of interest since the last session

(a) UNECE and subsidiary bodies

The secretariat will present the decisions taken by the 2009 session of the Committee on Trade and by the 2008 session of the Working Party on Agricultural Quality Standards having an impact on the work of the Specialized Section.

3. Revision of the Standard Layout

The delegations will consider the proposal from the United Kingdom on quality tolerances that could be taken into account in the Standard Layout as well as in some standards.

(d) - (h) New Standards for berries, leafy vegetables, root vegetables, stalk vegetables, lambs lettuce (*Valerianella locusta*)

The delegation of Germany will present a set of draft standards. These proposals are made in the light of the new EC regulation implementing a general standard for fruit and vegetables and allowing this standard for the produce in question to be replaced by the UNECE standard. As the number of UNECE standards is limited for produce of only national or regional importance, German producers and traders propose to establish new UNECE standards for produce groups such as berries, leafy vegetables, root vegetables and stalk vegetables, and eventually integrate existing standards for special produce.

7. UNECE explanatory brochure for sweet peppers

The Specialized Section is expected to finalize the brochure on the basis of proposals collected from countries. The delegations will decide if the draft brochure and the Standard could be recommended to the Working Party for adoption.
