## II. ANNOTATIONS

### 1. Adoption of the agenda

The delegations will adopt the agenda.

### 2. Matters of interest since the last session

#### (a) UNECE and subsidiary bodies

The secretariat will present the decisions taken by the 2007 sessions of the Committee on Trade and of the Working Party on Agricultural Quality Standards having an impact on the work of the Specialized Section.

#### (b) Other organizations

Representatives of other organizations and country delegates will inform the Specialized Section about activities taking place in their agencies that are of relevance to the work of the Section.

The UNECE and Codex Alimentarius secretariats will provide information on the progress made in coordinating the work of the two organizations. They will present the results of the comparison of the UNECE and Codex standard layouts and of the conformity certificates.

#### (c) Concentration of agricultural quality standards work in the UNECE

UNECE and OECD will report on the progress made in discussions on the concentration of the OECD and UNECE activities in agricultural quality standards within UNECE.

### 3. Standard Layout

The Specialized Section will revise the Standard Layout, which was adopted by the Working Party for a trial period until the end of 2008.

#### **4. Revision of UNECE standards**

##### **(a) Early and ware potatoes**

At its 2007 meeting the Specialized Section asked the Working Group on Early and Ware Potatoes, comprising representatives of Belgium, France (rapporteur), Germany, Ireland, Netherlands, Poland, the United States and Europatat, to review the French proposal for introducing quality classes in the Standard for Early and Ware Potatoes. They will present the results of their discussions.

##### **(b) Table grapes**

The Specialized Section will revisit the minimum maturity requirements.

##### **(c) Apples**

The Specialized Section will discuss the proposals on uniformity in size by France and the European Commission. The delegation of Italy will suggest how the list of apple varieties in the Standard should be managed and how grouping apple varieties by colour could be improved. The OECD Working Group on apples will propose amendments to the Standard.

##### **(d) Kiwifruit**

The text of the UNECE Standard for Kiwifruit was amended in January 2008 in conjunction with the work on the OECD explanatory brochure. The amendments proposed by the Bureau were to align the text of the Standard with the UNECE Standard Layout. The Specialized Section accepted them after consultation through the list server.

##### **(e) Pears**

The Specialized Section will discuss the amendments to the UNECE Standard for Pears proposed by the OECD Working Group on the explanatory brochure for pears.

**(f) Sweet peppers**

The Standard for Sweet Peppers will be discussed under item 8 in conjunction with the work on the UNECE explanatory brochure.

**(g) Other standards**

The Specialized Section may wish to revise other standards provided that interested countries have submitted written proposals.

**5. Review of UNECE recommendations**

The delegations will review the following recommendations, all adopted by the 2007 session of the Working Party for trial use until 2008.

**(a) Apricots**

The Specialized Section will consider the outstanding issues of russeting, single minimum size irrespective of quality class, maximum permissible ranges for uniformity in different classes, and possible reference to Brix levels in measuring maturity.

**(b) Cucumbers**

The Specialized Section will finalize provisions on sizing bearing in mind that size is not a quality-related parameter for cucumbers, and that sizing can be done by weight, length and diameter.

**(c) Peaches and nectarines**

At its 2007 meeting the Specialized Section asked Italy (Rapporteur) and other producing countries to do further work on provisions on sizing and maturity requirements. The delegation of Italy will report on the results of this work.

## **6. New UNECE standards**

### **(a) Chanterelles**

The secretariat will present the revised questionnaire on the use of UNECE standards, the restructured website of the Working Party and the updated list of authorities. Any other issues of interest for the work of the Specialized Section can be discussed under this agenda item.

The Specialized Section will elect a Chair and Vice-Chair. At its fifty-third session the group elected Ms. Ulrike Bickelmann (Germany) as Chair and Ms. Kristina Mattsson (Sweden) as Vice-Chair.
