The Chairperson and the secretariat will inform the participants on the outcome of the November 2007 session of the Working Party: (a) its new terms of references and working procedures; (b) approved 2007 versions of the standards for bovine, caprine and turkey meat; and (c) the questionnaire on national application of UNECE standards.

The secretariat will report on the status of the publications on the standards for bovine, caprine, chicken, llama/alpaca, ovine, porcine and turkey meat.

The Specialized Section will consider draft texts of revised standards for eggs-in-shell and for egg products. The participants will be invited to review the draft and propose changes/amendments and decide whether the text should be submitted to the Working Party for approval.

#### **6. New UNECE standard for edible meat co-products**

Documentation: Draft new UNECE standard for edible meat co-products  
(ECE/TRADE/C/WP.7/GE.11/2008/6)

The Specialized Section will consider the proposal prepared by the Working Group formed by the delegations of Australia, France and the United States on a new UNECE standard for edible meat co-products, also often referred to as offal, fancy meats, variety meats and edible by-products. The participants will be invited to review the draft and propose changes/amendments and decide whether the text should be submitted to the Working Party for approval.

#### **7. New UNECE standard for duck meat – carcasses and parts**

Documentation: Draft new UNECE standard for duck meat – carcasses and parts  
(ECE/TRADE/C/WP.7/GE.11/2008/7)

The delegation of China will present the draft of the standard discussed at the November rapporteurs' meeting in Moscow. The Specialized Section is expected to finalize the text and recommend it to the Working Party for approval.

#### **8. Preparation of 2008 session of the Working Party on Agricultural Quality Standards**

The Specialized Section will be invited to decide which decisions/information should be transmitted to the 2008 session of the Working Party.

**11. Election of officers**

The Specialized Section will elect a Chairperson and Vice-Chairperson. At its sixteenth session, the group elected Mr. Ian King (Australia) as its Chairperson and Mr. Craig Morris (United States) as its Vice-Chairperson.

The Specialized Section will be invited to adopt the report of the session.
