Item 4. **Specialized Section on Standardization of Seed Potatoes**

In the past year the Specialized Section focused on promoting the Standard on Seed Potatoes worldwide. The work on the Standard was carried out at the meetings of the Extended Bureau. The Specialized Section did not have time to meet in Geneva to endorse the amendments to the Standard and recommend them for approval by the Working Party.

Item 5. Specialized Section on Standardization of Fresh Fruit and Vegetables

The Specialized Section revised the text of the Standard Layout and recommended that the Working Party adopt it as a new Standard Layout.
