1. Adoption of the agenda

3. Specialized Section on Standardization of Meat

Owing to the volcanic ash cloud which made it impossible for delegates to attend the scheduled April session of the Specialized Section on Standardization of Meat, the meeting had to be postponed to 21 and 22 October 2010. Therefore, the report can only be presented to the Working Party in late October. Revised documents might become available in English shortly before the meeting. The Chair of the Specialized Section might outline and explain revisions which are for adoption by the Working Party.

At its November 2010 session, the Specialized Section will align a number of standards with the 2009 Standard Layout and will decide on submitting them to the Working Party for approval.
