Note by the secretariat

The objective of this document is to:

- Highlight ongoing cooperation with other organizations and outline recent developments
- Make transparent the framework within which the Committee and its subsidiary bodies cooperate with other organizations.

INTRODUCTION

The United Nations Economic Commission for Europe (UNECE) enjoys well-structured cooperation and coordination with United Nations Headquarters and with other organizations within and outside the United Nations system.

In the current planning period (2004 to 2005), we are paying especial attention to strengthening cooperation with the other regional commissions of the United Nations, the United Nations Conference on Trade and Development (UNCTAD) and the World Trade Organization (WTO), to maintain an environment that fosters intergovernmental policy dialogue.

At the regional level, we are promoting further economic integration through studies and capacity-building activities such as seminars, workshops and advisory services. In addition, we are working to strengthen the policies and institutions of transition economies for implementing sustainable development.

We continue to encourage the business community and non-governmental organizations to take part in all aspects of our work.

HIGHLIGHTS OF 2003/2004

Several high-level events were organized in cooperation with the European Commission and various international organizations within and outside the United Nations system. The most significant of these events were the following.

- (a) UNCTAD-UNECE High-level Regional Conference for Transition Economies
"ICT and E-Commerce Strategies for Development", Geneva, 20-21 October 2003

This Conference focused on the development of ICT, e-business and e-commerce in the transition economies and discussed appropriate policies and strategies that can enhance the capacities of these countries to use or even produce ICT-related technologies, primarily in the area of e-business and, in particular, e-trade applications. Participants shared local, regional and global experiences in policy formulation and implementation of ICT and e-commerce strategies and discussed how to make transition and developing economies and their enterprises more competitive and able to produce and sell higher-value-added products and services through global e-marketplaces.

- (b) The Geneva phase of the World Summit on the Information Society (WSIS)
(10-12 December 2003)

We contributed significantly to the organization of the first phase of the WSIS in Geneva by:

- Participating in the High-Level Organizing Committee (HLSOC) and in the UN Information and Communication Technologies (ICT) Task Force;
- Co-organizing the Bucharest Regional Preparatory Conference;
- Coordinating the input of all five United Nations regional commissions;
- Working closely with the WSIS Executive Secretariat to organize parallel events to the Geneva WSIS and a High-Level Roundtable on "ICT as a tool to achieve the Millennium Development Goals".

Our involvement in the WSIS process offered us a valuable opportunity to strengthen cooperation with a large number of United Nations and non-United Nations organizations, such as the WSIS Executive Secretariat, the United Nations ICT Task Force, UNCTAD, the United Nations Educational, Scientific and Cultural Organization, the United Nations Development Programme, the International Telecommunication Union, the Organisation for Economic Co-operation and Development, Eurostat, the World Bank and other regional commissions of the United Nations.

(c) Joint UNECE-OSCE Workshop on the Economic Dimension of Security in Europe, March 2004

Together with the Organization for Security and Cooperation in Europe (OSCE), the UNECE organized this joint Workshop to examine the implications of European Union enlargement for the economic dimension of security in the region. The workshop presented an opportunity for both organizations to discuss their respective roles in cooperating to implement the new OSCE Strategy Document for the Economic and Environmental Dimension.

COOPERATION WITH THE EUROPEAN COMMISSION

The European Commission regularly participates in and contributes to the UNECE's intergovernmental meetings and events. We also maintain regular, informal consultations with European Commission officials.

Our "Wider Europe" project, aimed at addressing the challenges and implications of EU enlargement for the UNECE region, particularly for transition countries, provided an opportunity for closer cooperation between the two organizations. For instance, the European Commission provided speakers and participated in two major "Wider Europe" workshops:

- *EU Enlargement. Regulatory Convergence in Non-Acceding Countries* – held on 7-8 November 2003 in Athens;
- *Transport Infrastructure Development for a Wider Europe* – held on 27-28 November 2003 in Paris.

COOPERATION WITH OTHER INTERNATIONAL ORGANIZATIONS

The following two charts describe our current cooperation with other United Nations and international bodies under the two subprogrammes of the Committee for Trade, Industry and Enterprise Development.
