




ISO/CASCO Structure


- 111 ISO members are represented in CASCO (73 participating members and 38 observers).
- Sixteen international organizations are liaison members of CASCO: BIPM, CEOC, CAC, EOQ, Eurolab, IAF, IFAN, IFIA, IIOC, ILAC, INLAC, IPC, IQNet, ITU-T, OIML, UILI.
- Both policy and technical work
- Continual improvement cycle





Chairman's Policy and Coordination Group (CPC)

- Gives recognition to the policy role of CASCO and oversees the internal coordination of the CASCO subgroups
- Studies conformity assessment issues
- Sets priorities for current and future CASCO work items
- Creates possible recommendations for endorsement by CASCO on conformity assessment



Strategic Alliance and Regulatory Group (STAR)

- Provides mechanism for industry sectors and regulators to interact with CASCO
- Alerts CASCO of sector and regulator activity in conformity assessment
- Forum to discuss conformity assessment concerns of industry sectors and regulators
- Promotes the CASCO toolbox to international agencies (regulators) and sectors
- Members:
 - CASCO Members (13);
 - A-Liaisons (5): IEC, IAF, ILAC, IQNet, CAC;
 - Special Members (4): EC, IATF, IRIS, UNECE
- Responsible for issues related to workshops, market surveillance, monitoring the credibility of certification of MSS

Technical Interface Group (TIG)


- Focused on the technical relationship between CASCO and ISO/TC's to ensure:
 - A harmonized approach by all TC's to conformity assessment
 - CASCO conformity assessment policies are understood and adhered to where relevant
 - The provision of advice internally in ISO on conformity assessment
 - The provision of advice to TC's on the design and development of sector specific schemes where justified

CASCO Interpretation Process

- Provides a uniform consistent approach to interpretation and maintenance of existing standards and guides
- Combination of quick response and a detailed response
- Responses are available on ISO website
- Accepted by all major players as the official interpretation structure
- Two interpretations done to date
 - ISO/IEC 17021- clause 6 Impartiality completed
 - ISO/IEC Guide 65- clause 15 Complaints to suppliers completed
- 6 more interpretations are being processed (4 on ISO/IEC 17021 and 2 on ISO/IEC 17011)

The ISO/CASCO Toolbox

- The CASCO toolbox consists of 27 documents covering:
 - Vocabulary, principles and common elements of conformity assessment
 - Code of good practice
 - Product, system, and persons certification
 - Testing, calibration, inspection, marks of conformity
 - Supplier's declaration of conformity, accreditation, peer assessment, and mutual recognition arrangements



- ISO/IEC 17021 Part 2 (CASCO WG 21), Conformity assessment Requirements for 3rd party certification auditing of management systems (DIS)
- ISO/IEC 17043 (CASCO WG 28), Conformity assessment Requirements for proficiency testing (publication expected in early 2010)
- ISO/IEC 17065 (CASCO WG 29), Conformity assessment Requirements for certification bodies certifying products (including services) and processes (CD)
- ISO/IEC 17024 (CASCO WG 30), Conformity assessment General requirements for bodies operating certification of persons (WD)
- ISO/IEC 17020 (CASCO WG 31), Conformity assessment General criteria for the operation of various types of bodies performing inspection (WD)
- ISO/IEC 17067 (CASCO WG 32), Conformity assessment Fundamentals of product certification
- ISO/IEC TS 17022 (CASCO WG 33), Conformity assessment Third party audit reports




Topical issues related to conformity assessment

- IAF-ILAC-ISO action plan on monitoring the effectiveness of accredited management system certification
 - Harmonized sanctions
 - Develop metrics to measure CB's level of activity
 - AB Assessor competence
 - Validation audits
 - Market feedback
- Transfer of knowledge through workshops on topical issues at every CASCO plenary:
- 2009 plenary Role of International Standards in managing the global supply chain and traceability



Topical issues related to conformity assessment


- Market surveillance develop an information document on Good Practice for use by developing economies and how to promote existing standards to regulators
- Identifying best practice within successful sectors (automobile, aeronautics, telecoms railways etc) and determining if they can be transposed to the CASCO toolbox
- Annual management survey on MSS
- Risk management
- Developing countries and CASCO and UNIDO/DEVCO/CASCO publications
 - Most recent is publication of "Building Trust"



CASCO promoting energy efficiency and sustainability

- CPC set up a task group to make recommendations on sustainability and energy efficient buildings
- Task group has 4 objectives:
 - Review the current CASCO toolbox to determine if existing standards can be used or there is a need for new standards
 - Identify those standards where there is a need for more specific requirements
 - Determine how best to accommodate any specific conformity assessment requirements
 - Investigate the impact on the current CASCO toolbox of extending conformity assessment procedures to urban and city areas






Conclusions on Conformity Assessment

- A global framework for conformity assessment will increase consumer and regulator confidence by:
 - Providing a common interpretation of test results
 - Providing a mechanism for acceptance of certificates and reports
 - Achieving consistency and building confidence in products and services
 - Applying to International Standards a principle of neutrality
 - Defining good practices for market surveillance.
