- Note 1:** At its twentieth session, the Committee of Experts elected Mr. S. Benassai (Italy) and Mr. F. Wybenga (United States of America) respectively Chairman and Vice-Chairman for the 1999-2000 biennium (ST/SG/AC.10/25, para. 152).
- Note 2:** A working group on the transport of gases (item 2) will be convened in parallel on Monday 6 December in the afternoon after discussion of item 2 in plenary session. The working group will continue working in parallel during the first week as necessary and will report back to the Plenary.
- Note 3:** The deadline for submission of documents is **17 September 1999**. Delegations are invited to submit their proposals as soon as possible and not later than **17 September**, and to inform the secretariat at the latest by **10 September** of any document in preparation that would not have yet been submitted.
- Note 4:** For reasons of economy, delegations are invited to keep their own copies of documents and to bring them to the meeting.

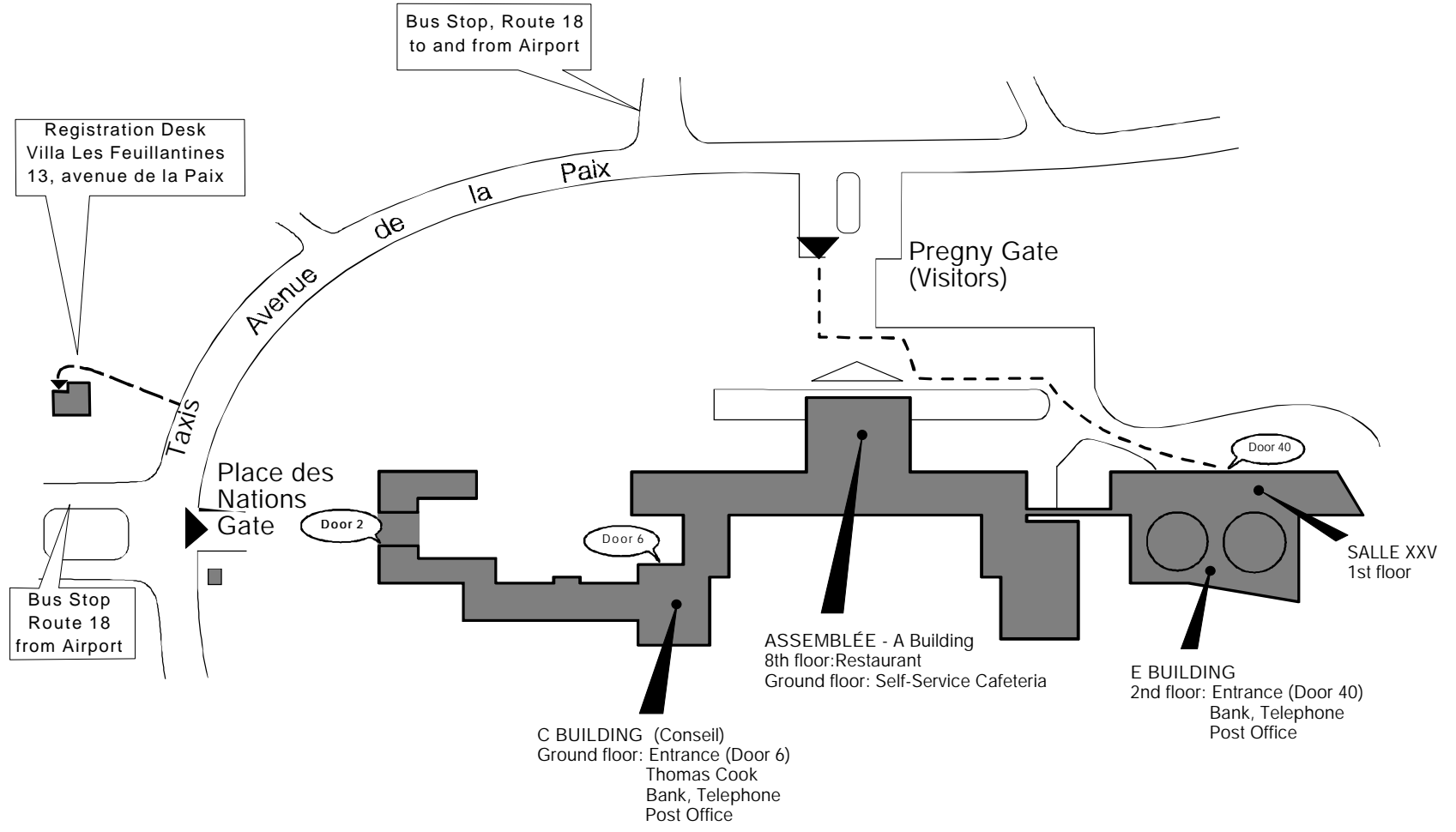
